SUBJECT: Amendment to the Professional Service agreement between the County of Riverside and Anthony Firek, M.D.

RECOMMENDED MOTION:

- 1) Ratify the amendment to the Professional Services agreement with Anthony Firek, M.D. November 1, 2102;
- 2) Authorize the Chairperson to sign three (3) copies of the amendment;
- 3) Retain one (1) copy and return two (2) copies of the executed amendments to RCRMC for distribution.

BACKGROUND: Effective July 1, 2001, an agreement was executed with Anthony Firek, M.D. to provide weekly half-day endocrinology clinics for the Hospital's outpatient clinics. This amendment increases the weekly half-day endocrinology clinic to a three-quarter day clinic each week, to increase access and appointment availability for endocrinology specialty care professional services.

This amendment has been approved as to form by County Counsel.

**FOURTH AMENDMENT
TO THE
AGREEMENT
BETWEEN
COUTY OF RIVERSIDE
AND
ANTHONY FIREK, M.D.**

That certain Agreement between the County of Riverside (COUNTY), a political subdivision of the State of California, on behalf of the Riverside County Regional Medical Center (HOSPITAL) and Anthony Firek, M.D., dated July 1, 2001 and amended on July 1, 2003, July 1, 2010 and June 1, 2011 is hereby amended effective November 1, 2012, pursuant to the following:

1. Delete Section 1.0, Exhibit A in its entirety and replace with the following:

"1.0" Subject to the conditions set forth below, HOSPITAL shall pay CONTRACTOR a total not to exceed thirty-nine thousand dollars (\$39,000) per year for administrative, supervisory, teaching, consultations, and medical care services at Riverside County Regional Medical Center. Endocrine Clinic payment provisions shall be at the rate of SIX HUNDRED (\$600) DOLLARS per half-day clinic. A half-day clinic is defined as a minimum of four (4) hours in a 24-hour period. An additional THREE HUNDRED (\$300) DOLLARS will be paid for each additional quarter-day clinic provided within the same 24-hour period of time. A quarter-day clinic is defined herein as a minimum of two (2) hours in a 24-hour period. Payments to CONTRACTOR shall be made on a monthly basis during the Term of this Agreement. HOSPITAL shall pay CONTRACTOR payments by the invoice method specified below:"

2. Delete Section 3.0, Exhibit A in its entirety and replace as follows:

"3.0 Maximum Annual Compensation

Maximum annual compensation payable under this Agreement shall not exceed sixty-nine thousand (\$69,000) dollars."

All other terms and conditions of this Agreement are to remain in full force and effect.

IN WITNESS WHEREOF, the Parties hereto have caused their duly authorized representatives to execute this Amendment.
