SUBJECT: Amendment to the Professional Medical Services agreement with Inland Empire Cardiology Faculty Medical Associates, Inc.

RECOMMENDED MOTION:

- 1) Ratify the amendment with Inland Empire Cardiology Faculty Medical Associates effective January 1, 2013;
- 2) Authorize the Chairperson to sign three (3) copies of the amendment;
- 3) Retain one (1) copy and return two (2) copies of the executed amendments to Riverside County Regional Medical Center (RCRMC) for distribution.

BACKGROUND: Inland Empire Cardiology Faculty Medical Associates, Inc. provides a full range of cardiology and cardiac diagnostic services to patients at RCRMC on an inpatient, outpatient and emergency basis. In addition to the services noted above, Dr. Krishnan began providing Cardiac Defibrillator implantation services at RCRMC in 2009 which allowed patients previously transferred to other hospitals to remain in the County. This additional professional service has resulted in savings for RCRMC and

**SECOND AMENDMENT
TO THE
AGREEMENT
BETWEEN
COUNTY OF RIVERSIDE
AND
INLAND EMPIRE CARDIOLOGY FACULTY MEDICAL ASSOCIATES, INC.**

That certain Agreement between the County of Riverside (COUNTY), a political subdivision of the State of California, on behalf of the Riverside County Regional Medical Center (HOSPITAL) and Inland Empire Cardiology Faculty Medical Associates, Inc.(CONTRACTOR) effective October 1, 2008 and amended on June 1, 2011 is hereby amended effective January 1, 2013, pursuant to the following:

1. Delete Section 2.5.1 in its entirety and replace with the following:

"2.5.1 Services to be provided for adults will include, but not be limited to, ambulatory clinical services, development of treatment protocols, supervision of stress echocardiography, transesophageal echocardiography, dobutamine echocardiography, holter monitors, EKG's, cardiovascular stress tests, pacemaker testing, in addition to operating room procedures including cardiac catheterization, pacemaker implantation, defibrillator implantations, and intracardiac electrophysiology studies (EPS) and additional cardiology diagnostic testing (as applicable)."

2. Delete Section 1.0, Exhibit A in its entirety and replace with the following:

"1.0. Subject to the conditions set forth below, HOSPITAL shall pay CONTRACTOR a total of six hundred fifty thousand (\$650,000) dollars per year for the services of two (2) full-time physicians from CONTRACTOR's Medical Group to provide cardiology clinical services, administrative duties, supervisory duties, teaching services, inpatient care, operating room procedures, development of policies, treatment protocols and supervision of cardiology services for the Hospital. Payments to CONTRACTOR shall be made on a monthly basis during the Term of this Agreement. HOSPITAL shall pay CONTRACTOR payments by the invoice method specified below:"

3. Delete Section 3.0, Exhibit A in its entirety and replace with the following:


"3.0 Maximum Annual Compensation

Maximum annual compensation payment under this Agreement shall not exceed six hundred fifty thousand (\$650,000) dollars."


All other terms and conditions of this Agreement are to remain in full force and effect.




