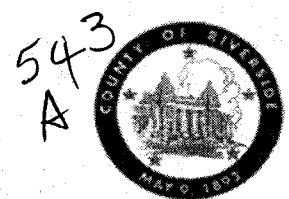

**BACKGROUND:** An Off Highway Vehicle (OHV) Commission was established in 2006 under the Riverside County Planning Department to advise and make recommendation to the Board of Supervisors concerning the identification of sites for OHV parks, site acquisition issues, range and use of candidate sites, and advice on public outreach for educational and informational purposes. The duration of the OHV Commission and its members terms ended December 31, 2010, per M.O. 3.9, January 13, 2009.

**SUBJECT:** Riverside County Off-Highway Vehicle Recreation Appointed and Reappointed Commission Members and Terms - District ALL

**BACKGROUND:**

As such, the Commission was re-established under the District through Resolution 2011-7 to serve in an advisory capacity to the District Board of Directors to assist with the planning, acquisition, development and use of OHVR parks within the District.

The OHVR Commission consists of the following five (5) initial members, each of whom have been appointed and recommended for reappointed to serve at the pleasure of the Board of Supervisors:

Vacant	(1 <sup>st</sup> District)	4 year appointment ending 6/30/14
Jon Christensen	(2 <sup>nd</sup> District)	4 year appointment ending 6/30/16
Anthony Migliore	(3 <sup>rd</sup> District)	4 year appointment ending 6/30/14
Ryan Stendell	(4 <sup>th</sup> District)	4 year appointment ending 6/30/16
Vacant	(5 <sup>th</sup> District)	4 year appointment ending 6/30/14

It should be noted that at the same time the OHVR Commission was established under the District (Resolution 2011-7), it was also established under the County Parks (Resolution 2011-039). Since the same members serve on both Commissions, it is recommended that appointments that are made to serve on the County Parks OHVR Commission also serve as companion appointments to the District OHVR Commission, with like terms.
