SUBJECT: Amendment to Professional Medical Services Agreement

RECOMMENDED MOTION:

- 1) Ratify the First Amendment to the agreement with Faculty Physicians and Surgeons of Loma Linda School of Medicine effective February 1, 2013;
- 2) Authorize the Chairperson to sign three (3) copies of the amendment;
- 3) Retain one (1) copy and return two (2) copies of the executed amendments to Riverside County Regional Medical Center for distribution.

BACKGROUND: Beginning in August 2008 the Faculty Physicians and Surgeons of the Loma Linda School of Medicine (FP&S) agreed to provide part time forensic professional and on-call services along with Rady Children's Hospital, through its Chadwick Center, as part of the Hospital's Child Abuse and Neglect program. Effective February 1, 2013, FP&S will assume full responsibility for the on-call services for the Hospital's Child Abuse and Neglect program.

The amendment has been approved as to form by County Counsel.

FIRST AMENDMENT
TO THE
PROFESSIONAL MEDICAL SERVICES
BETWEEN
COUNTY OF RIVERSIDE
AND
FACULTY PHYSICIANS AND SURGEONS OF LOMA LINDA
UNIVERSITY SCHOOL OF MEDICINE

7 That certain Agreement between the County of Riverside (COUNTY) on behalf of the
8 Riverside County Regional Medical Center (HOSPITAL) and Faculty Physicians and Surgeons
9 of Loma Linda University School of Medicine (CONTRACTOR) effective November 1, 2008 is
10 hereby amended effective February 1, 2013, pursuant to the following:

11 1. Delete Exhibit A, Section 1.0 in its entirety and replace as follows:

14 "1.0 Subject to the conditions set forth below, HOSPITAL shall pay CONTRACTOR one
15 hundred sixty two thousand, eight hundred (\$162,800) dollars for the services of one (1) .50
16 professional to provide administrative services and oversight for the HOSPITAL Child Abuse
17 and Neglect (CAN) clinic, peer review of all child abuse medical examinations, develop
18 medical protocols for evaluation of suspected child abuse and neglect, and to provide
19 administrative, supervisory, teaching services and to direct patient care. In addition to the
20 above, HOSPITAL shall pay CONTRACTOR an additional fifty-one thousand, two hundred
21 (\$51,200) dollars per year for on-call coverage and telephone consultation to the HOSPITAL
22 Emergency Room, Child Protective Services, law enforcement, SANE's or County District
23 Attorney's office. CONTRACTOR agrees to assist appropriate COUNTY authorities in the
24 development of forensic guidelines for evidence collection and preservation, case review
25 protocols, and protective services. The total payment includes an incentive for meeting
26 performance requirements listed in Section 1.2 below. Payments to CONTRACTOR shall be

made on a monthly basis during the Term of the Agreement. HOSPITAL shall pay
CONTRACTOR payments by the invoice method specified below."

2. Delete Exhibit A, Section 3.0 in its entirety and replace as follows:

"3.0 Maximum Annual Compensation

Maximum annual compensation payable under this Agreement shall not exceed
two hundred fourteen thousand (\$214,000) dollars."

All other terms and conditions of this Agreement are to remain in full force and effect.




