Born and raised in Oklahoma City, Patrick received his degree in architecture from the University of Oklahoma and moved to San Francisco in 1965. As a recognized architect specializing in historic preservation for over 45 years, his projects included the restoration of San Francisco's Historic City Club as well as the terracotta-clad offices of 20 California Street. He authored many books, including Landmarks of San Francisco and The Historic Houses of Presidio Terrace and was appointed to the San Francisco Landmarks Board, serving as President for 14 years.

In 2005, Patrick moved to Palm Springs, where he became an instrumental force in the community. His emphasis on establishing the architectural pedigree of the town's Spanish and mid-century architecture and "scrupulous research methodology" brought noteworthy attention to his work. He also served on the City's Historic Site Preservation Board, the Architectural Advisory Committee, the Palm Springs Preservation Society, and was Chair of the Palm Springs Art Museum's Architecture and Design Committee at the time of his death.

Patrick is survived by his life-partner of 25 years, author and actor, Robert Julian Stone. His memory and passionate spirit will live forever in the hearts of those who knew and loved him. He will be dearly missed.
