## **BACKGROUND:**

Operation SafeHouse provides emergency shelter, intervention and outreach services to run away, homeless, and other youth in crisis. This funding is intended for the SafeHouse of the Desert that serves more than 250 youth annually in the Thousand Palms shelter.

The Cathedral Center serves the senior communities of Cathedral City and Rancho Mirage. The programs they provide include educational, recreational and entertainment. The assist with health care referrals, social programs, low income housing and assisted living referrals, home weatherization and other programs. The Coachella Valley Autism Society of America assists over 150 families in the Coachella Valley. This funding will allow them to reach out to more families with children who have autism and provide resources that they can access.

Rec-N-Crew Foundation raises funds for the City of Blythe's Recreational Department that would otherwise not be able to provide youth programs in the area.

The Riverside County Regional Medical Center Foundation raises funds for the Child Abuse and Neglect (CAN) Unit at RCRMC.
