Treasurer's Pooled Investment Fund

"The Great Debate, Cont."

Last month we reported that the New Year started with a bang as the equities market exploded in gains. We are happy to report that those gains continued into the month of February. On February 1, the Dow Jones Industrial Average (DJIA) traded above 14,000 for the first time since October 2007, closing at 14,009.79. The rally though will not have a direct effect on the TPIF yield as we are strictly a fixed income investor, however, pension funds should see some much needed relief. We hope this trend continues as it is a favorable sign of the general health and recovery of the economy.

The Fed released its Summary of Commentary on Current Economic Conditions, otherwise known as the beige book, which affirmed that the economy grew at a, "modest to moderate pace" in February. The Non-Farm Payroll report confirmed growth in the jobs sector with a gain of 236,000 jobs and a decrease in the unemployment rate to 7.7% from 7.9% in January. Both numbers improved more than expected.

Unfortunately, we cannot report that the ongoing fiscal debate in Washington has been resolved. Current talk continues to circle around the infamous sequester and imminent debt ceiling increase. If you recall, this is a repeat, or better yet, a continuation of two years ago. In the summer of 2011, the federal government raised the debt ceiling to keep from defaulting on its obligations. As part of the 2011 agreement between the White House and Congress to raise the debt ceiling, sequestration then became the promise. The sequestration was never intended to take effect, but

rather be used as a threat to force Congress to come to an agreement on how to reduce the U.S. national debt which is currently over \$16 trillion, and counting.

Continued stalemate will cause the spending cuts to automatically occur on March 1 and is supposed to reduce spending by \$85 billion in 2013. Congressional leaders and the President are not in favor of across the board cuts, but have failed to come to an agreement on how the cuts should be made, or how much taxes should be raised.

Let us also not forget that the debt limit of \$16.4 trillion has been extended until May 19, 2013. If the great debate continues and no resolution is reached, then the debt ceiling will have to be raised once again. Remember last time, the increase in the debt ceiling spurred a downgrade of the U.S. credit ratings by Standard and Poor's. The TPIF along with many other bonds funds with large holdings of U.S. Treasuries and government agencies were put on review for possible downgrade. Luckily, the TPIF maintained its AAA rating by both Moody's and Fitch.

We hope Congressional leaders can come to an agreement in order to shield the sovereign debt rating of this nation and prevent an increase in the cost of borrowing which may trickle down to states, counties, and cities across the nation. We will continue to monitor the great debate in Washington and as always, prudently manage the Treasurer's Pooled Investment Fund in the best interests of our depositors.

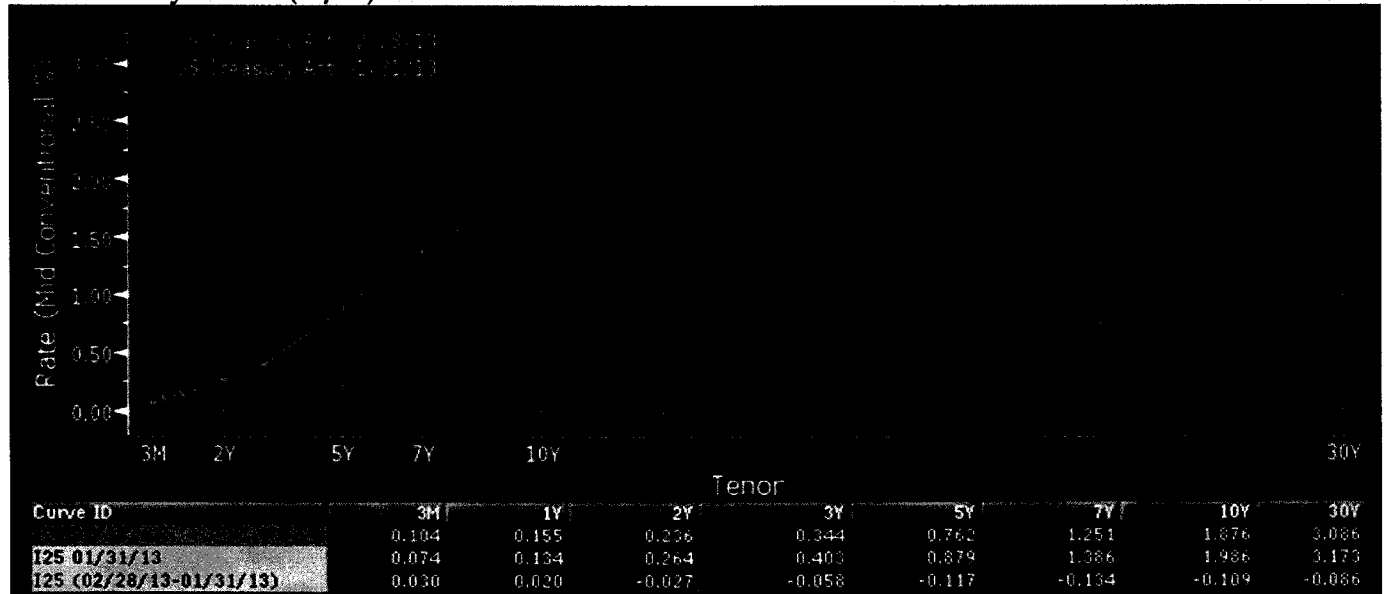

US Treasury Curve (M/M)

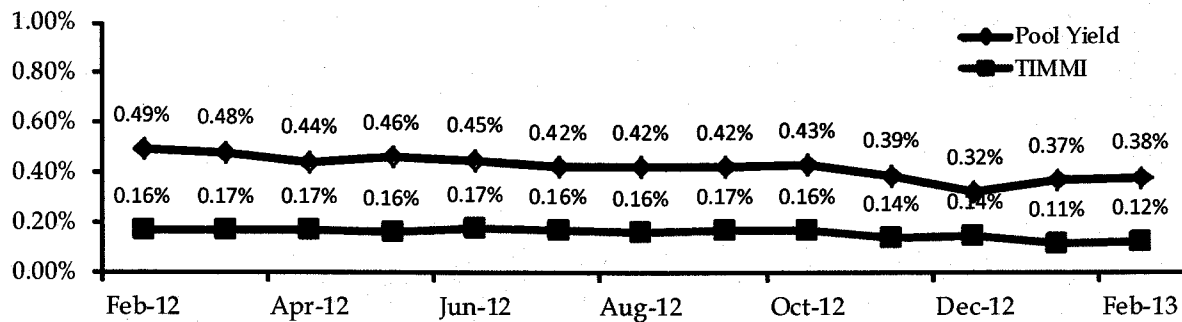


TIMMI

The Treasurer's Institutional Money Market Index (TIMMI) is compiled and reported by the Riverside County Treasurer's Capital Markets division. It is a composite index derived from five AAA rated prime institutional money market funds. Similar to the Treasurer's Office, prime money market funds invest in a diversified portfolio of U.S. dollar denominated money market instruments including U.S. Treasuries, government agencies, commercial paper, certificates of deposits, repurchase agreements, etc. TIMMI is currently comprised of the five multi billion dollar funds listed below.

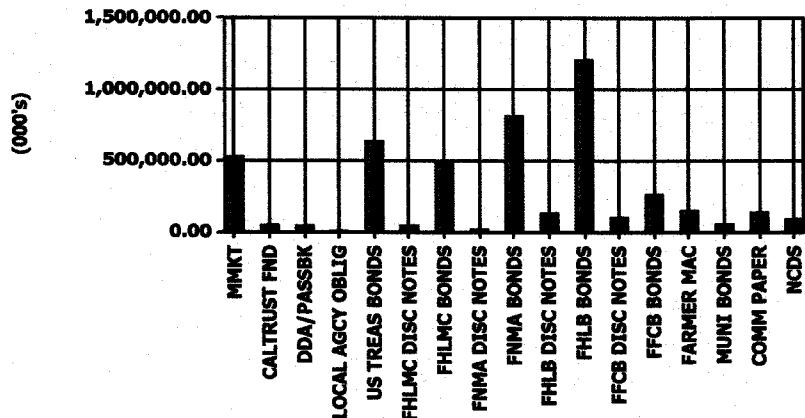

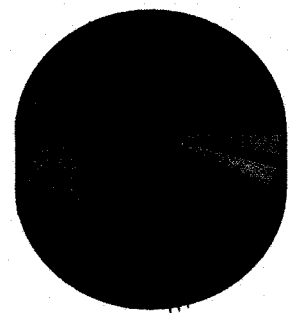

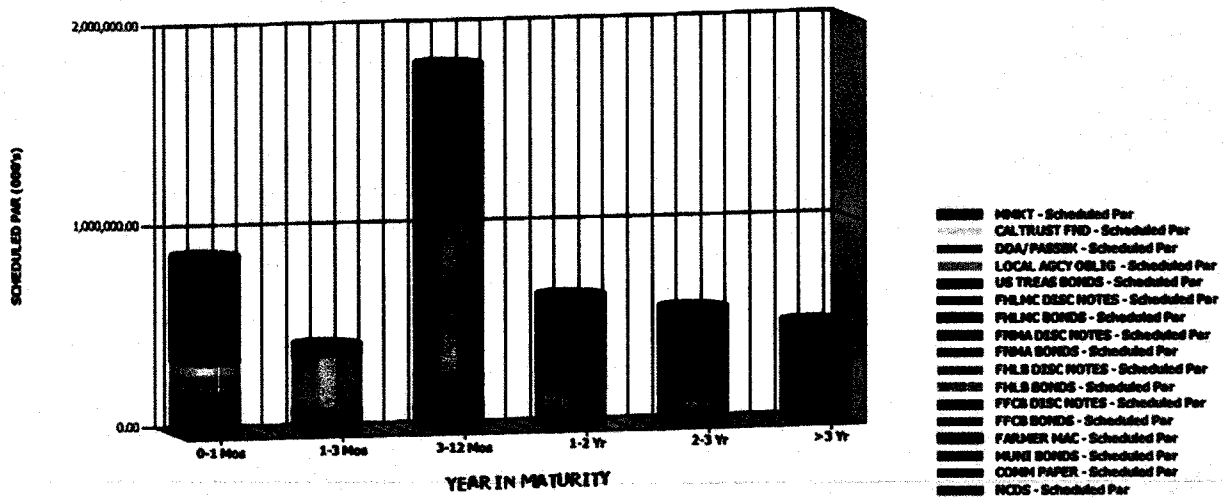
SCHEDULED PAR %

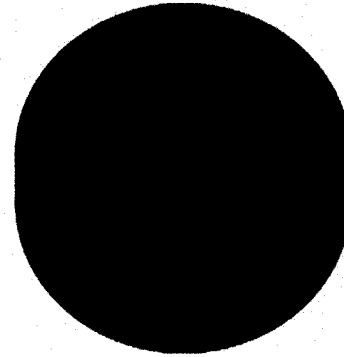
