**SUBJECT:** Criminal Justice Administration Fee Charge to Convicted Individuals

**RECOMMENDED MOTION:** That the Board of Supervisors approve a criminal justice administration fee in the amount of \$434.08 for FY 12/13 that will be charged to individuals convicted of a crime following arrest by a county officer and booking at a Riverside County jail.

**BACKGROUND:** Government Code §29550 (c) states that any county whose officer arrests a person is entitled to recover from the arrested person a criminal justice administration fee for administrative costs it incurred in conjunction with the arrest if the person is convicted of any criminal offense related to the arrest, whether or not it is the offense for which the person was originally arrested. The county notifies the court regarding the fee (in a manner specified by the court) and upon conviction the judge imposes an order of payment. The order is issued in the same manner as a civil judgment but is not enforceable by contempt. Furthermore, the court will, as a condition of probation, order the convicted person, based on ability to pay, to reimburse the county for the criminal justice fee. Fee calculation is attached to the previous agenda item.
