BACKGROUND:

By Minute Order dated January 29, 2013 (Agenda Item 3-46), the Board authorized the Clerk of the Board to advertise for the construction of a traffic signal and lighting at the intersection of Ramon Road and Monterey Avenue/Sierra Del Sol, in the Thousand Palms area.

Bids for the project were opened in the office of the Director of Transportation and Land Management at 2:00 p.m., Wednesday, February 20, 2013. Ten bids were received, ranging from \$218,812 to \$316,143.

The basis for the selection of a contractor is the lowest responsive and responsible bid. The lowest responsible bid was submitted by PTM General Engineering Services, Inc. in the amount of \$218,812, which is \$12,577 (6%) more than the Engineer's Estimate.

The Transportation Improvement Program (TIP) provides for the construction of the subject improvements. The traffic signal will improve traffic operation and safety. The work includes the installation of traffic signals, safety lighting, sidewalk and access ramps, and associated improvements.

The Development Impact Fee (DIF) program, which is governed under Ordinance 659.6, allows for the use of DIF funds for traffic signal facilities.

Annual traffic signal operation and maintenance costs are estimated at \$5,500 for this location, which will be funded from gas tax.

The project is expected to be completed within the existing budget as shown on Attachment A.

Reasonable care has been taken during the design phase to determine the location of underground utilities, including research of information from the local utility providers and communication with the utility owners. Given the uncertainties associated with doing undergrounding work, there is a potential for additional costs during construction to locate conflicting utilities by pot-holing and excavating and to make field construction changes as needed to avoid utilities. A contingency has been included in the construction budget, to be utilized only if deemed necessary by the Transportation Department, to cover the costs of resolving utility conflicts.

The contractor is qualified to perform the work as outlined in the bid, and has executed the contract and provided bonds and insurance documents, which meet the requirements of the contract.

AGREEMENT

THIS AGREEMENT is entered into at Riverside, California as of the date set forth below is between County of Riverside hereafter called "County" and **PTM General Engineering Services, Inc.** hereafter called "Contractor".

WITNESSETH

RECITALS:

1. Contractor has submitted to County his Contractor's Proposal for the construction of County Project, **Ramon Road and Monterey Avenue / Sierra Del Sol, Traffic Signal and Lighting Project, Thousand Palms Area. Project No. C2-0151**, in strict accordance with the Contract Documents identified below and County has accepted said Proposal.
2. Contractor states that he has reexamined his Contractor's Proposal and found it to be correct, has ascertained that his subcontractors are properly licensed and possess the requisite skill and forces, has reexamined the site and Contract Documents and is of the opinion that he can presently do the work in accordance with the Contract Documents for the money set forth in his Proposal to be paid as provided in the Contract Documents.

AGREEMENT:

IT IS AGREED BY THE PARTIES AS FOLLOWS:

1. Contract Documents. The entire contract consists of the following: (a) The Agreement. (b) The Notice Inviting Bids. (c) The Instruction to Bidders. (d) The Contractor's Proposal. (e) The Bid Bond. (f) The Payment Bond. (g) The Performance Bond. (h) The General Conditions. (i) The Special Provisions. (j) The Standard Specifications of the State of California Department of Transportation edition of May 2006 as modified in other portions of the Contract Documents. (k) The Standard Plans of the Department of Transportation identified on the plans or in the Special Provisions. (l) The Plans. (m) Addenda No. **(one)**. (n) The Determination of Prevailing Wage Rates for Public Work. (o) Any Change Orders issued. (p) Any additional or supplemental specifications, notice, instructions and drawings issued in accordance with the provisions of the Contract Documents. All of said Documents presently in existence are by this reference incorporated herein with like effect as if here set forth in full and upon the proper issuance of other documents they shall likewise be deemed incorporated. The Bid Bond is exonerated upon execution of this Agreement and the Payment Bond and Faithful Performance Bond.
2. The Work. Contractor shall do all things necessary to construct the work generally described in Recital No. 1 in accordance with the Contract Documents.

3. Liquidated Damages and Time of Completion. Attention is directed to the provisions in Section 8-1.06, "Time of Completion", and in Section 8-1.07, "Liquidated Damages", of the Standard Specifications and these Special Provisions.

The Contractor shall begin work within 15 days of the date stated within the written "Notice to Proceed".

The Contractor shall notify the Engineer, in writing, of his intent to begin work at least 72 hours before work is begun. The notice shall be delivered to the Transportation Department's Construction Engineer and shall specify the date the Contractor intends to start. If the project has more than one location of work, a separate notice shall be given for each location.

Should the Contractor begin work in advance of receiving a written "Notice to Proceed", any work performed by him in advance of the date stated in the "Notice to Proceed" shall be considered as having been done by him at his own risk and as a volunteer and subject to the following:

- (1) The Contractor shall, on commencing operations, take all precautions required for public safety and shall observe all the provisions in the Specifications and the Special Provisions.
 - (2) All work done according to the contract prior to the issuance of the "Notice to Proceed", will be considered authorized work and will be paid for as provided in the contract.
 - (3) The Contractor shall not be entitled to any additional compensation or an extension of time for any delay, hindrance or interference caused by or attributable to commencement of work prior to the issuance of the "Notice to Proceed".
4. Compensation. Contractor shall be paid in the manner set forth in the Contract Documents the amount of his Proposal as accepted by County, the above rates, subject to additions and deductions as provided in the Contract Documents. Said Proposal is on file in the Office of the Clerk of the Board of Supervisors of County.
