The Board approved a contract with KIP, Incorporated, in the amount of \$5,138,077.15 as Agenda Item Number 11.4 on March 13, 2012. The District does not anticipate any claims for additional compensation from the Contractor, therefore, the total project construction cost is not expected to exceed the original contract amount.

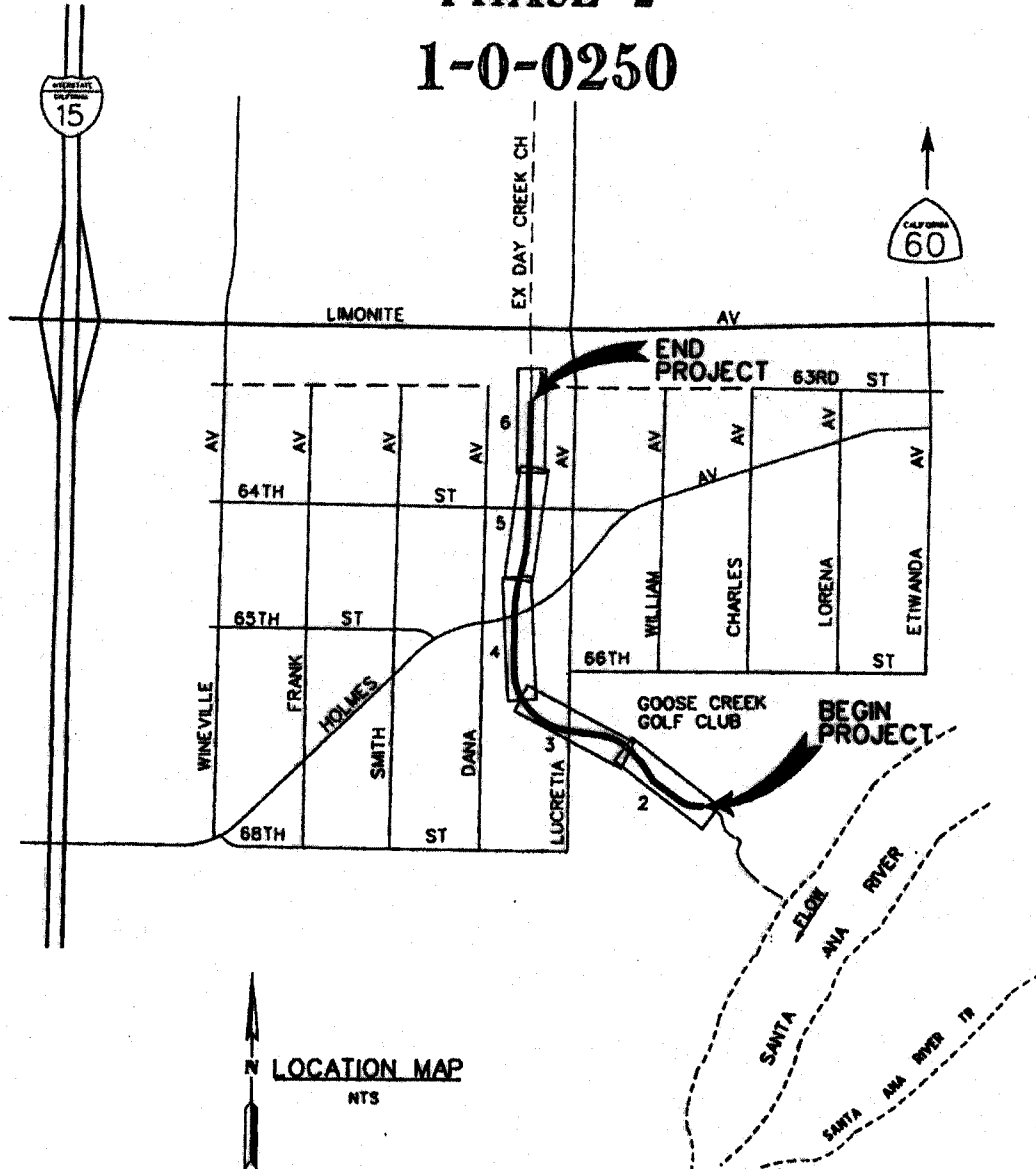
Final inspection of the above referenced project was made, and the project was found to be complete according to plans and specifications. A brief project description and location map are attached.

The Day Creek Channel, Stage 6 Phase 2 project involves the construction of approximately 1,100 lineal feet of rock lined trapezoidal channel and approximately 2,700 lineal feet of concrete lined rectangular channel. The proposed project is located in the city of Jurupa Valley, Riverside County. The proposed project begins within Goose Creek Golf Club, approximately 1,150 lineal feet downstream of Lucretia Avenue. The improvements extend upstream and tie into the existing concrete lined channel located approximately 600 lineal feet downstream of Limonite Avenue. A reinforced box culvert is proposed to raise the "Arizona crossing" at Lucretia Avenue to provide 100-year storm conveyance capacity. Improvements will be made below the existing bridges at Holmes Avenue and 64th Street to provide 100-year storm conveyance capacity.


