But those who knew him remember Mr. Moore first as a quiet, modest, gentleman who cared deeply about his family and the city where he lived for more than 50 years.

Mr. Moore died early Monday, April 29, at home after a long battle with cancer. He had just been honored by the City Council, which voted April 16 to name a planned nature center at Sycamore Canyon Wilderness Park after him.

In January, he published a book about his life, and friends said he was especially proud of it.

County buying newspaper's office building

A.H. Belo Corp. has agreed in principle to sell the five-story building housing The Press-Enterprise to Riverside County for approximately \$30 million, the company announced Monday, April 29.

Press-Enterprise Publisher and CEO Ronald R. Redfern announced the pending transaction in an email to employees Monday afternoon. The sale, which is based on a non-binding letter of intent, is expected to close in the third quarter of this year. Assuming that happens, the company plans to relocate to leased office space within Riverside city limits, Redfern wrote.

The building would become home to the county's information technology department, said county spokesman Ray Smith. The department is trying to consolidate its services, a move county officials said could save \$40 million to \$60



Born in 1934 in a logging camp in the segregated South, Mr. Moore's family settled a few years later in rural White Sand, Miss., according to his book, "My Memoirs: Climbing Up the Downstair Escalator.

In high school he met Henrietta Silas, whom he later married. Referring to the cost of the marriage license, he wrote, "My two-dollar investment in Henrietta was the best I ever made. She has been a faithful and loving wife."

Mr. Moore enlisted in the U.S. Air Force in 1955 and served for eight years, including posts in the Philippines and Greenland, before he was honorably discharged in 1962. By then, Mr. Moore and his young family had settled in Riverside, and after leaving the Air Force he took a job with the U.S. Postal Service.

YEARS OF SERVICE

Over the years, Mr. Moore was president of Riverside's NAACP chapter, helped form a Toastmasters International club, taught Sunday school at his church, and served on the city's parking and traffic and planning commissions.

He was elected in 1994 to represent the City Council Ward 2, including the Eastside, parts of the university

Friends said that, in the wake of Miller's shooting, Mr. Moore was instrumental in the creation of a multicultural council and the Community Police Review Commission.

Friends said several of Mr. Moore's experiences in Riverside, including Miller's death, were affected by an older wound that had never healed; the 1965 murder of his brother Oneal, one of Louisiana's first black deputy sheriffs, by the Ku Klux Klan. No one was ever prosecuted for the crime.

"Nothing has ever made me as angry as Oneal's death," Mr. Moore wrote in his memoir.

Mayes said Mr. Moore's memory of his brother drove his involvement in community activities, such as finding a site for a Martin Luther King Jr. statue in Riverside.

"Ameal was remarkably even-keeled," said former mayor Ron Loveridge, whom Mr. Moore unsuccessfully ran against for mayor in 2005. "It wasn't because he didn't have strong views, but he brought kind of a balanced way of presenting those."

Steve Moore said his father "didn't make rash decisions. Whatever he was thinking about doing one day, if he slept on it and he still felt that way the next day, he would do it."

Mr. Moore led a full and varied life, from facing discrimination during his rural upbringing to raising a closeknit, spiritual family to serving in elected office for 12 years and traveling to South Africa, China and elsewhere, Steve Moore said.

Katie Greene, who belongs to the Toastmasters club Mr. Moore helped faund, described him as likable, caring and "a people's politician."

He was especially proud of his council service and would often give speeches on it, she said.

"I think he's going to be remembered for the strength of his convictions and his fairness and willingness to lend a listening ear," she

Mr. Moore is survived by his wife, Henrietta; sons Jeffery and Steve and their wives, son Carl; and four grandchildren. Services will be announced later. Mr. Moore will be buried in Riverside National Cemetery.
