agreements or other documents as approved by County Counsel that are necessary for the relocation of SCE Distribution facilities, which are in conflict with the Clinton Keith Road extension project, provided that the additional costs total \$100,000 or less.

**BACKGROUND:**

The Transportation Improvement Program (TIP) provides for the extension of Clinton Keith Road, from I-215 to SR-79, in the Murrieta Area. The project is being constructed in phases to expedite construction. The first phase of the project, between I-215 and Whitewood Road, was recently completed by the City of Murrieta. The second phase to be constructed will be the segment between Whitewood Road and Trois Valley Street. This Segment is to be constructed to half width, providing one lane in each direction ("Project"). The section between Trois Valley Street and Leon Road is fully constructed, thereby, effectively creating full connectivity between I-215 and SR-79 (with the completion of this next phase, via Leon Road and Max Gilliss Boulevard).

The second half of the segment between Whitewood Road and Trois Valley Street and the segment between Leon Road and SR-79 will be constructed in subsequent phases as funding becomes available. Construction for the next phase is anticipated to begin in 2014.

The Project requires the relocation of electric distribution facilities owned by SCE, which are in conflict with the Clinton Keith Road project. The County is required to pay all costs associated with the relocations, inasmuch as SCE has superior property rights for most of the affected facilities. SCE has completed a significant amount of the design work for the relocation of their facilities. Due to the complexity of the relocation design, SCE is requiring that a design agreement for the reimbursement of design costs be executed to cover their costs prior to the relocation of the facilities. The four Preliminary Design and Engineering Agreements are for performing work related to the installation, removal, relocation, rearrangement and/or replacement of SCE facilities at:

1. Clinton Keith Road between Whitewood Avenue and Menifee Road for the relocation of poles.
2. Clinton Keith Road between Whitewood Avenue and Menifee Road for underground relocation.
3. Clinton Keith Road between Menifee Road and Trois Valley for the backbone line extension.
4. Clinton Keith Road between Menifee Road and Avenue Manana for joint relocations.

The Board of Supervisors is requested to execute the four attached agreements associated with the work performed by SCE to date. This approval will authorize payment of the associated invoices, totaling \$275,171. The work was anticipated through Supplemental Environmental Impact Report 398. Additionally, the costs were authorized under the annual TIP.

Additional reimbursement costs for final design and for the physical relocations will be covered under a separate agreement(s).

**PRELIMINARY DESIGN AND ENGINEERING AGREEMENT**

The Agreement is between Southern California Edison Company ("SCE") and

COUNTY OF RIVERSIDE, ("Applicant")  
Applicant may request at a future date that Southern California Edison Company perform work related to the installation, removal, relocation, rearrangement and / or replacement ("WORK") OF SCE's electric service facilities at

THE JOINT RELOCATION FROM MENIFEE RD TO AVE MANANA

TD 620248

Applicant therefore requests that SCE estimate the cost to perform the WORK. SCE must incur certain expenses for preliminary design and engineering of the WORK in order to estimate the cost to perform the WORK contemplated by the APPLICANT. Applicant agrees to pay SCE for such expenses under the following terms and conditions:

1. Applicant shall pay SCE the sum of \$36,826.61 in advance for expenses incurred by SCE for preliminary design and engineering of the WORK contemplated by Applicant.
2. If Applicant desires SCE to perform the WORK contemplated by the Applicant, Applicant shall execute a separate written contract to perform the WORK. If SCE performs the WORK contemplated by Applicant pursuant to a contract executed by Applicant within one year from the date herein, the sum paid to SCE by Applicant pursuant to this Agreement shall be applied without interest to whatever sums are payable by Applicant pursuant to the contract to perform the WORK. The sums required by the contract to perform the WORK, may include costs for additional design and engineering related to the WORK contemplated by the Applicant.
3. The sum paid by Applicant pursuant to this Agreement shall be forfeited to SCE if (a) Applicant requests SCE to perform the WORK but the WORK cannot be completed through no fault of SCE's, or (b) Applicant fails within one year from the date herein to execute a written contract for SCE to perform the WORK.
4. SCE may require Applicant to pay an additional sum pursuant to the agreement if SCE must modify the scope of the preliminary design and engineering as a result of any change in the WORK contemplated by the Applicant.
5. This Agreement shall not be construed as a contract to provide electric service to Applicant or as a contract to perform the WORK contemplated by Applicant.
