


SUBJECT: Riverside County Small Business Expo

**RECOMMENDED MOTION:** That the Board of Supervisors endorse Riverside County's involvement in the Small Business Expo and direct the County Transportation Department and Economic Development Agency (EDA) to participate and assist with this event.

**BACKGROUND:** On June 27, 2013 the County will be participating in a Small Business Expo that is a cooperative venture of the Riverside County Transportation Commission (RCTC), Caltrans, the Riverside Transit Agency (RTA), and the County. Riverside County, in cooperation with our regional partner agencies and our Cities, has embarked on a significant building program to deliver transportation infrastructure. Many projects are under construction now and more will be going out to bid in the next couple of years.

This Expo is geared towards providing outreach and assistance to our small businesses that are interested in pursuing contracting opportunities with public agencies. Those attending the Expo will learn about upcoming projects, network with other small businesses and prime contractors, learn about the qualification process for Disadvantaged Business Enterprises (DBE), and have an opportunity to be added to future bid notices.




