



BACKGROUND:

The College of the Desert Public Safety Academy provides an educational opportunity to students that want to pursue a career in public safety. I would like to designate funds for a scholarship to be provided to the Spring 2013 semester.

Jewish Family Services of San Diego is in the process of making major improvements at Nightengale Manor, a facility that will house disabled persons in Palm Springs. The City of Palm Springs and Jewish Family Services have provided \$ 128,000 towards this project. The counties' contribution will cover the cost of equipment and bathroom fixtures.

The College Voc-Tec Night 2013 is taking place on Oct. 16th at the Riverside County National Date Festival Fairgrounds. The event is hosted by the following high schools; Desert Mirage, Coachella Valley, Amistad, La Familia and West Shores. Over 3000 students and their parents are expected to attend and have the opportunity to meet with representatives for colleges, technical and vocational institutions, military branches and some employers.

The 2013 Veteran's Expo event will take place on Oct. 12th at the Riverside County Fairgrounds. The resource fair will include a variety of vendors and expects to have over 500 veterans and their families in attendance. I would like to support the College Voc Tec Night and Veteran's Expo by contributing the funding needed to cover the cost of the facility.
