BACKGROUND: Riverside County currently has six YOC(s) located in Hemet, Lake Elsinore, Rubidoux, Indio, Perris and Moreno Valley. On February 4, 2013, Riverside County Economic Development Agency (EDA) issued a Request for Proposal (RFP) to solicit service providers to operate the six YOCs, effective Jul 1, 2013.

A review panel consisting of staff from a cross-section of outside public, non-profit, education and workforce professionals evaluated the proposals based upon the criteria outlined in the RFP. The various agencies were scored and the review panel made the following funding recommendations for each YOC as detailed in the table below:

The recommended agencies listed above shall perform activities as outlined in the proposed Scope of Work and requirements as set forth in the RFP. However, if the selected bidder is unable to complete a successful contract and budget negotiation process, EDA reserves the right to conduct a new procurement of lead agencies to operate the applicable YOC(s).

The valid procurement period for this RFP is July 1 2013, through June 30, 2016. Funding recommendations for subsequent program years will be conducted annually based on funding availability and satisfactory performance.

This funding recommendation was approved by the Riverside County Workforce Investment Board on April 10, 2013.
