**SUBJECT:** Annual Renewal of Medically Indigent Services Program (MISP) and Riverside County HealthCare Program (RCHC) Payments Authorization for Medical Service Providers.

**RECOMMENDED MOTION:** Move that the Board of Supervisors:

- 1) Authorize the Medically Indigent Services Program (MISP) and Riverside County HealthCare Program (RCHC) to pay for medical services and pharmaceuticals without securing competitive bids in accordance with Ordinance 459.4 for Fiscal Year 2013-14;
- 2) Exempt the Purchasing Agent from the requirement to report sole source agreements when adding medical services providers and pharmaceutical vendors to the existing list of providers;
- 3) Authorize the Medically Indigent Services Program (MISP)/Riverside County HealthCare Program (RCHC) to pay for medical and pharmaceutical services not to exceed the annual aggregate amount of \$16,000,000.

**SUBJECT: Annual Renewal of Medically Indigent Services Program (MISP) and Riverside County HealthCare Program (RCHC) Payments Authorization for Medical Services Providers.**

**BACKGROUND:** This is the annual re-authorization. The MISP/RCHC budget houses the funding to pay for the Medically Indigent Services Program established in 1983 and the Low Income Health Program (LIHP) established Jan 2012 for those adults between the ages 19-64 and 0% to 133% Federal Poverty Level established locally as the Riverside County HealthCare Program (RCHC). This budget also funds the cost of non-County medical providers used by Detention Health Services, Juvenile Halls, and the higher levels of care referral needs that Riverside County Regional Medical Center (RCRMC) cannot provide.

Although the transition of the majority of the MISP uninsured to the Riverside County Healthcare (RCHC) Program took place during FY2011-12, the MISP claims unit will continue to function as the fiscal intermediary for the reimbursement of medical services and pharmaceuticals rendered to the remaining medically indigent enrollees that do not qualify for the RCHC program, as well as the county adult and juvenile prisoners, and other necessary medical services that the hospital does not provide. As patients enroll in the Low Income Health Program (LIHP) there will be a need for them to access out-of-county emergency room and Hospital Facility services. Payment for out-of-network emergency and post-stabilization services are governed by the Department of Health Care Services at 30% of the "Rogers Rate". For services where there are no Medi-Cal fees available, the payment rate will be at 35% of Billed Charges. MISP/RCHC may change its payment rates to remain within the statutory payment rate requirements as set by the State of California Department of Health Care Services each year. Authorization levels are as follows:

There may be a transition of dollars between the MISP and RCHC/LIHP payment authorization levels as the continued migration of MISP to RCHC enrollment occurs and after the end of the LIHP program there will continue to be outstanding claims submitted that will need to be processed and paid.

**PRICE REASONABLENESS:** MISP and RCHC will continue to reimburse its providers using mostly Medi-Cal rates which are established by the State of California Department of Health Care Services. There is no negotiation regarding the reimbursement rates set as they are priced to the State Medi-Cal fee schedule and in some cases the Medicare fee schedule or a Medi-Cal equivalent rate when the Medi-Cal fee structure is too complex to implement such as Home Health Services. When there are no willing providers, a separate negotiated rate will be established. The department is requesting to continue to pay for these services without seeking competitive bids.

**FUNDING:** There are sufficient revenue sources in the Department's proposed budget to fund the requested expenditures. The indigent care costs of MISP and RCHC are mainly funded through State realignment sales taxes and vehicle license fees (California Welfare and Institutions Code 17600), Detention Health Services (DHS), Juvenile Halls, RCRMC, Low Income Health Program (LIHP) Federal reimbursement, and other department revenues. The requested authorization for payments funding for Fiscal Year 2013-14 is \$16,000,000 which includes estimated payments to both MISP and RCHC out of county providers.

**FINANCIAL IMPACT:** There will be no financial impact. Funding for the program is already included in the 2013/14 budget and there will be no new net County costs.
