SUBJECT: Approval of the First Amendment to the Law Enforcement Services Agreement with the City of Palm Desert

BACKGROUND: On May 14, 2013, the Mayor of Palm Desert approved the First Amendment to the city's law enforcement services Agreement with the County Sheriff's Department. This Amendment provides for a no-cost redeployment of eight Patrol officers to dedicated positions for service billing purposes.

In addition, the city is discontinuing its part-time utilization of an Office Assistant II position, which has been vacant since November, 2012. This position had been split among Indian Wells, Palm Desert and Rancho Mirage. The Board deleted this position per Resolution 440-8926, included in its approval of the First Amendment to the Law Enforcement Services Agreement with the city of Indian Wells (4/23/13 3.54). County Counsel has approved the Amendment as to form.

**FIRST AMENDMENT TO AGREEMENT FOR LAW
ENFORCEMENT SERVICES BETWEEN COUNTY
OF RIVERSIDE AND CITY OF PALM DESERT**

IT IS MUTUALLY AGREED that the agreement for Law Enforcement Services between the County of Riverside, a political subdivision of the State of California, on behalf of its Sheriff's Department and the City of Palm Desert, a Charter City, approved by the Board of Supervisors on October 18th, 2011, for services effective July 1st, 2011 through June 30th, 2014, is hereby amended in the following respects, and all other terms and conditions of the Agreement remain in full force and effect:
