**SUBJECT:** Approval of the Fourth Amendment to the Agreement with Keefe Group, Keefe Commissary Network to Provide Commissary Services for the Sheriff's Correctional Facilities

**RECOMMENDED MOTION:** Move that the Board of Supervisors:

1. Approve and authorize the Chair to execute the fourth amendment to the Keefe Group, Keefe Commissary Network Agreement, adding one year to the agreement and extending the period of performance until October 31, 2015, and;

2. Approve a modification in the monthly commission rate remitted to the Sheriff's Inmate Welfare Fund, changing it from a fixed amount to a shared commission rate of 44.1% on all

commissionable commissary sales, and;

**BACKGROUND:** On September 29, 2009, (3.68) the Board of Supervisors approved a three (3) year agreement with the option of two (2) one-year renewal periods with Keefe Group, Keefe Commissary Network to provide commissary services for the Riverside County Sheriff Department's five (5) correctional facilities throughout Riverside County.

On December 1, 2009, County Purchasing approved the first amendment to the agreement adding several commissary items to the menu. On December 1, 2011, County Purchasing approved the second amendment to the agreement modifying its payment procedure to the Inmate Welfare Trust Fund.

In FY 2011-12, in an effort to avoid staff layoffs and the possible disbanding of inmate programs and services, the Sheriff's Corrections Division considered a proposal to use Inmate Welfare Funds (IWF) to reimburse the County for the funds appropriated to Sheriff's Inmate Training and Education Bureau (SITE-B). Staff conducted an analysis of the bureau's core functions, legal requirements, potential effects from suspension, and options were considered to determine the fiscal sustainability of the proposal along with the best course of action. Staff concluded from the analysis that IWF revenue with supplemental AB 109 revenue provides adequate funding for SITE-B, and implemented this budget change in FY 2012-13.

IWF generates revenue from multiple sources including commissary item sales to in-custody inmates. In the last quarter of calendar 2012, in an effort to increase IWF revenue, the Sheriff's Department began negotiations with Keefe Group to transition from a fixed commissary commission payment to IWF, based on inmate headcount, to a revenue stream based on a profit sharing model for commissary commissions, a commission model similar to that implemented by other neighboring county jail systems. When the contract with Keefe reached the end of year three in November 2012, Purchasing approved the third amendment to the agreement, modifying the contract to a month to month agreement. The third amendment was issued in order to continue commissary service to the jails while the County renegotiated specific items in the contract with Keefe or issued an RFP for new commissary contract.

The Sheriff's Department has satisfactorily concluded its negotiations with Keefe Group, and now recommends to the Board, with County Purchasing concurrence, approval of the fourth amendment to the Keefe Group agreement. This amendment would provide the following:

- A one year extension to the contract, extending the term until October 31, 2015
- Keefe will provide the IWF a 44.1% commission on all commissionable commissary sales
- Keefe will amend the Commissary Pricing Schedule (see Exhibit B, attached subsequent to the Amendment). In summary, the amended Schedule includes a number of new commissary items, and the maximum price change on any one item is a \$0.50 increase on some hygiene items.
- Keefe will provide a generic scantron ordering form for in-custody inmates and provide a "Friends & Family" website for internet sales

 Keefe will provide deposit services via web, phone, and seven onsite lobby kiosks at all County jails

Staff estimates that the 44.1% commission rate will increase annual commission payments from \$609,000 to \$1.1 million. These additional funds would be directly deposited into the Inmate Welfare Fund (IWF) to fund the Sheriff's Inmate Training and Education Bureau (SITE-B). All the provisions of this amendment shall be made by Keefe Group at no cost to the County.

### COUNTY OF RIVERSIDE AMENDMENT NO.4 TO THE AGREEMENT WITH KEEFE GROUP, KEEFE COMMISSARY NETWORK

### **CONTRACTOR:**

Keefe Group, Keefe Commissary Network November 1, 2009 through October 31, 2015

Effective Date of Amendment: July 2, 2013

The Agreement between Riverside County, herein referred to as COUNTY and Keefe Group, Keefe Commissary Network, herein referred to as CONTRACTOR, is amended as follows:

- 1. On page 3 of the Agreement, amend Section 3 Compensation, all references to the Compensation: Monthly Commission rate will be 44.1% on all commissionable commissary sales.
- 2. CONTRACTOR shall provide generic commissary order form at no charge to the County. Contractor shall provide a computerized menu at no charge to the County.
- 3. CONTRACTOR will provide Deposit Services via web, phone, seven lobby kiosks and will responsible for all costs to set-up the kiosks at the Riverside County Sheriff Detention Facilities.
  - a. Fee Structure:
    - i. Deposit of \$0.99 to \$20.00 Fee is \$1.00
    - ii. Deposit of \$20.01 to \$40.00 Fee is \$2.00
    - iii. Deposit of \$40.01 to \$200.00 Fee is \$3.00
- 4. On page 24 of the Agreement, amend Exhibit B Commissary Pricing Schedule: New Exhibit B Commissary Pricing Schedule (pages 1-4) is attached to this Amendment.
- 5. All other terms and conditions of the Agreement are to remain unchanged.
