If the owner or whoever has possession or control of the real property does not take the above described action within ninety (90) days of the date of the Board's Order to Abate, that representatives of the Code Enforcement Department, Sheriff's Department, and/or a contractor, upon consent of the owner or receipt of a Court Order authorizing entry onto the real property, when necessary under applicable law, may abate the accumulation of rubbish by removing and disposing of the same from the real property.
- 4. The reasonable costs of abatement, after notice and an opportunity for hearing, shall be imposed as a lien on the real property, which may be collected as a special assessment against the real property pursuant to Government Code Section 25845 and Riverside County Ordinance No. 725.
- 5. County Counsel be directed to prepare the necessary Findings of Fact and Conclusions that the accumulation of rubbish on the real property is declared to be in violation of Riverside County Ordinance No. 541, and a public nuisance, and further, to prepare an Order to Abate for approval by the Board.

BACKGROUND:

- 1. An initial Inspection was made on the subject property by Code Enforcement Officer Lori Lyon on October 4, 2012. The inspection revealed the accumulation of rubbish on the subject property in violation of Riverside County Ordinance 541. The rubbish consisted of, but was not limited to: discarded construction material, discarded lumber and plywood, styrofoam, toys, tires, green waste and miscellaneous debris.
- 2. Subsequent follow up inspections of the above-described real property on October 25, 2012, January 22, 2013 and January 29, 2013, revealed the property continues to be in violation of Riverside County Ordinance No. 541.
- 3. Staff and the Code Enforcement Department have complied with the notice requirements set forth in the appropriate laws of this jurisdiction pertaining to the administrative abatement proceedings for the removal of accumulated rubbish.

I, Lori Lyon, declare that the facts set forth below are personally known to me except to the extent that certain information is based on information and belief which I believe to be true, and if called as a witness, I could and would competently testify thereof under oath:

- 1. I am currently employed by the Riverside County Code Enforcement Department as a Code Enforcement Officer. My current official duties as a Code Enforcement Officer include inspecting properties for violations and enforcement of the provisions of Riverside County Ordinances.
- 2. On October 4, 2012, I conducted an initial inspection of the real property described as Parcel West of 21510 Ethanac, Good Hope, Riverside County, California and further described as Assessor's Parcel Number 345-020-019 (hereinafter described as "THE PROPERTY"). A true and correct copy of a Thomas Brothers map page indicating the location of THE PROPERTY is attached hereto and incorporated herein by reference as Exhibit "A."
- 3. A review of County records and documents disclosed that THE PROPERTY is owned by Juan A. Abreu (hereinafter referred to as "OWNER"). A certified copy of the County Equalized Assessment Roll for 2012-2013 tax year and a copy of the report generated from the County Geographic Information System ("GIS") is attached hereto and incorporated herein by reference as Exhibit "B."
- 4. Based on the Lot Book Report from RZ Title Service dated November 7, 2012, there appears to be no interested parties. A true and correct copy of the Lot Book Report is attached hereto and incorporated herein by reference as Exhibit "C."
- 5. On October 4, 2012, I arrived at THE PROPERTY to conduct an initial inspection of THE PROPERTY. From the road right of way, I observed accumulated rubbish, which consisted of, but was not limited to the following materials: discarded construction material, discarded lumber and plywood,

styroform, toys, tires, green waste and misc debris.

- 6. As a result of the accumulated rubbish, THE PROPERTY constituted a public nuisance in violation of the provisions set forth in Riverside County Ordinance ("RCO") No. 541.
- 7. On October 4, 2012, I posted a Notice of Violation and on October 11, 2012, a Notice of Violation was mailed to OWNER by first class mail.
- 8. True and correct copies of each Notice issued in this matter and other supporting documentation are attached hereto and incorporated herein by reference as Exhibit "D."
- 9. A site plan and photographs depicting the conditions of THE PROPERTY are attached hereto and incorporated herein by reference as Exhibit "E."
- 10. On October 25, 2012, and January 22, 2013, I conducted follow up inspections and observed that THE PROPERTY remained unchanged and in violation of RCO No. 541.
- 11. Based upon my experience, knowledge and visual observations, it is my determination that the conditions on THE PROPERTY are dangerous to the neighboring property owners and the general public.
- 12. Furthermore, a recent inspection showed THE PROPERTY remained in violation of RCO No. 541.
- 13. I am informed and believe and based upon said information and belief allege that the OWNER does not have legal authority or permission to store or accumulate the above described materials on THE PROPERTY.
- 14. A Notice of Pendency of Administrative Proceeding was recorded in the Office of the County Recorder, County of Riverside, State of California, on April 2, 2013, as Instrument Number 2013-0156619, a true and correct copy of which is attached hereto and incorporated herein by reference as Exhibit "F."
- 15. A "Notice to Correct County Ordinance Violations and Abate Public Nuisance" providing notification of the Board of Supervisors' hearing as required by RCO No. 725 was mailed to OWNER by first class mail and was posted on THE PROPERTY. True and correct copies of the notice, together with the proof of service, and the affidavit of posting of notices are attached hereto and incorporated herein by reference as Exhibit "G."






SITE PLAN CV12-05352




