SUMMARY OF ORDINANCE NO. 567.4

AN ORDINANCE OF THE COUNTY OF RIVERSIDE AMENDING ORDINANCE NO. 567 REGULATING FOOD HANDLERS

This summary is presented pursuant to California Government Code Section 25124(b); a certified copy of the full text of Ordinance No. 567.4 may be examined at the Office of the Clerk of the Board of Supervisors of the County of Riverside located at 4080 Lemon Street, 1st Floor, Riverside, California.

Ordinance No. 567.4 amends Ordinance 567, regulating Food Handlers, in order to reflect the availability of an on-line training and examination option available to the public. Additionally, it mandates timeframes for obtaining the training and examination for new applicants for criffication; clarifies exemptions available, and provides a detailed description of the appeal process for both the denial of a certification and/or a citation for failure to adhere to certification guidelines.

Ordinance 567 was adopted by the Board of Supervisors of Riverside County on November 29, 1977, and last amended November 24, 2009. The Riverside County Board of Supervisors approved a Form 11 allowing for the RFP process and choice of State Food Safety to provide on-line testing and examination services for the Riverside County Department of Environmental Health on November 27, 2012. A Form 11 to inflict the revision of Ordinance 567 was approved on April 23, 2013.
