SUBJECT: Timeshare Internet Tax Sale, TC-198 scheduled for October 24, 2013 through October 29, 2013.

RECOMMENDED MOTION: That the Board of Supervisors:

- 1) Approve the intended timeshare internet tax sale, TC-198, 2) Approve and adopt the provisions of the Revenue and Taxation Code Section 3698.5(a), 3698.5(c), 3706.1(a) and Section 4703(a), 3) Adopt resolution 2013-161 approving the sale of tax-defaulted property prepared and approved by County Counsel, and 4) Instruct the Clerk of the Board to immediately forward a certified copy of the Board's Resolution to the Tax Collector following Board approval.

The above action will authorize the minimum bid on timeshares to be offered for sale, via the internet. This action will set in motion the Tax Collector's sale in October.

BACKGROUND: Properties for which taxes are not paid are sold to collect back taxes. After the property has been tax-defaulted for a period of five or more years from the original tax-default year, it becomes subject to the Tax Collector's "Notice of Power to Sell Tax Defaulted Property," which is then recorded. If the property is not subsequently redeemed by the payment of all amounts due, it is offered for sale by the Tax Collector.

SUMMARY OF THE TIMESHARE INTERNET SALE:

The Tax Collector will offer a total of three hundred and one (301) intervals in two (2) timeshare projects. 1) Desert Breezes Resort located in Palm Desert and 2) Plaza Resort and Spa located in Palm Springs.

On October 24, 2013 8:00 AM through October 25, 2013 9:00 AM the Tax Collector will offer one hundred seventy-six (176) timeshare intervals at full redemption plus cost of sale. These intervals probably will not sell the first time offered because of the escalated minimum bid amount due to the several years of delinquent taxes and penalties that have accrued. Also, the Tax Collector will offer one hundred twenty-five (125) previously offered timeshare intervals for cost of sale only. These intervals have been previously offered at least once and no bids were received.

- One hundred sixteen (116) intervals from Desert Breezes Resort will be offered for the first time for a minimum bid of full redemption plus cost of sale per interval.
- Sixty (60) Plaza Resort and Spa will be offered for the first time for a minimum bid of full redemption plus cost of sale per interval.
- Forty-five (45) previously offered intervals from Desert Breezes will be reoffered at cost of sale only.
- Eighty (80) previously offered intervals from Plaza Resort and Spa will be reoffered at cost of sale only.

On October 25, 2013 through October 29, 2013, assuming the one hundred seventy-six (176) timeshare intervals do not sell by October 25, 2013 at 9:00 AM, they will now be reoffered at the same sale for a reduced minimum bid of cost of sale only.

As indicated in Exhibit "A" the aggregate minimum bid for all intervals is \$697,973.00

For this sale, if all parcels reoffered sell for the minimum bid, the maximum tax loss would be **\$218,042.64**. Taking into account the Teeter formula, which shares this loss with other taxing entities, the maximum loss to the Tax Loss Reserve Fund would be **\$120,032.47**. A sufficient balance exists in the Tax Loss Reserve Fund to allow for this loss and still transfer to the General Fund the surplus amount included in this year's budget. Therefore there is no direct budgetary impact.

8 WHEREAS, the Tax Collector of Riverside County intends to sell at public auction, over the
9 internet, tax-defaulted property subject to the power of sale, on October 24, 2013 through October 29, 2013
10 and requests that the Board of Supervisors of the County of Riverside, State of California approve the
11 intended sale, and any postponement of the sale that may be necessary; the Tax Sale List TC 198 Sale File
12 4383 is attached herewith as Exhibit "A" and sets forth the property declared tax-defaulted with the year of
13 the tax-default and the assessment number; the notice of the proposed sale will be sent to the State
14 Controller in accordance with Section 3700.5 of the California Revenue and Taxation Code; and

15 WHEREAS, the Tax Collector in his discretion has determined that the property specified in
16 Exhibit "A" attached hereto and incorporated by reference, should be offered for sale on October 24, 2013
17 through October 29, 2013 with the minimum bid to be in accordance with California Revenue and Taxation
18 Code Section 3698.5, and

19 WHEREAS, California Revenue and Taxation Code Section 3698.5 provides that, where
20 property has been offered for sale at least once and no acceptable bids have been received at the prescribed
21 minimum price, the Tax Collector may, in his discretion and with the approval of the Board of Supervisors,
22 offer that same property at the same or next scheduled sale at a minimum price that the Tax Collector
23 deems appropriate in light of the most current assessed valuation of that property or any unique
24 circumstance with respect to that property; and

25 WHEREAS, one hundred sixteen (116) timeshare intervals, or less, at Desert Breezes Resort
26 in Palm Desert will be offered at the tax sale for the first time for the full redemption amount plus cost of
27 sale, and if these timeshare intervals do not sell for the full redemption amount plus cost, they will be
28 reoffered later in the same sale at a reduced bid; and

1 WHEREAS, sixty (60) timeshare intervals, or less, at Plaza Resort and Spa in Palm Springs
2 will be offered at the tax sale for the first time for the full redemption amount plus cost of sale, and if these
3 timeshare intervals do not sell for the full redemption amount plus cost, they will be reoffered later in the
4 same sale at a reduced bid; and

5 WHEREAS, forty-five (45) previously offered intervals from Desert Breezes Resort in Palm
6 Desert will be reoffered at cost of sale only because they were previously offered and no bids were
7 received; and

8 WHEREAS, eighty (80) previously offered intervals from Plaza Resort and Spa in Palm
9 Springs will be reoffered at cost of sale only because they were previously offered and no bids were
10 received; and

11 WHEREAS, the Tax Collector has determined that due to unique circumstances that the
12 timeshare intervals that are being offered for the first time may not sell for the full redemption amount plus
13 cost of sale, therefore these intervals should be reoffered at the same sale at a reduced bid: and

14 WHEREAS, it is in the best interests of the State of California, the County of Riverside, and
15 cities, school districts, and special districts for whom the Tax Collector collects taxes, to sell said
16 properties; now, therefore,

17 BE IT RESOLVED, DETERMINED, AND ORDERED by the Board of Supervisors of the
18 County of Riverside, State of California, in regular session assembled on July 30, 2013 that the proposed
19 internet sale of tax-defaulted property subject to the power of sale and any continuation of the
20 sale is hereby approved and the Tax Collector of the County of Riverside is directed to offer the property
21 described in Exhibit "A" attached hereto and incorporated by reference, at public auction to the highest
22 bidder for cash in lawful money of the United States at the minimum bid set in accordance with California
23 Revenue and Taxation Code Section 3698.5(a) and 3698.5(c) as specified below:

24 1. One hundred sixteen (116) Desert Breezes Resort timeshare intervals, or less, will be
25 offered at a minimum bid of the full redemption amount plus the cost of sale on October 24, 2013 at 8:00
26 a.m. through October 25, 2013 at 9:00 a.m.

27 2. If the Desert Breezes Resort timeshare intervals do not sell at the full redemption
28 amount plus cost, they will be reoffered later at the same sale on October 25, 2013 at 9:00 a.m. through
October 29, 2013 at a minimum bid of the cost of sale.
