BACKGROUND: On June 18, 2013, agenda item 3-35, the Board approved the Cooperative Agreement with the City of Moreno Valley. As part of this Cooperative Agreement, Exhibit "C" outlines the Fire Engine Use Agreement as an option for all the Fire Department contract partners. Exhibit "C" gives each partner the option to transfer title of fire engines to the County. The City of Moreno Valley is requesting to transfer the title of four (4) fire engines to the County under this section of the Agreement.

## **BACKGROUND: (continued)**

Once the transfer is complete, these fire engines will be listed on the City of Moreno Valley's Cooperative Agreement as part of Exhibit "C" and the city will be responsible for the annual cost of the Fire Engine Use service of \$19,200 per engine. Per the Exhibit "C", the County will be responsible for the replacement of these fire engines when the Fire Department determines the fire engines are due for replacement.

The cost of maintenance and repair of these fire engines will continue to be the responsibility of the County. All fire engines are maintained by the Department and the costs are allocated per our annual Cost Allocation Plan. There will be no change in this current cost allocation with the transfer of these fire engines.
