**BACKGROUND:** On October 25, 2005, agenda item 3.21, the Board of Supervisors approved an Equipment Loan Agreement with CAL Fire for the Goodrich Rescue Hoist (Asset 076457). The Rescue Hoist is used on the CAL Fire helicopter #301 located at Hemet Ryan Air Base.

**BACKGROUND: (continued)**

The Rescue Hoist was originally funded with 99% grant funds and 1% County General Funds in November 2005, for a total of \$119,474. RCOFD is requesting to donate the Goodrich Rescue Hoist, serial number 30117, to CAL Fire in an effort to standardize testing, repair, and replacement. This will ensure that all of CAL Fire's helicopters have a serviceable hoist in the event their primary hoist is out of service due to maintenance or mechanical issues. Upon completion of the ownership transfer, Cal Fire will be responsible for all future associated costs of the rescue hoist. Cal Fire will ensure to the best of its abilities, that helicopter #301 will always have a hoist for use.
