BACKGROUND: Community Improvement Designation funds will be given to the following organizations:

1. **Habitat for Humanity Riverside, Inc. - \$2,000** to support Habitat for Humanity's "*Neighborhood Revitalization Initiative*" which aims to fight blight by building on vacant, city owned properties neglected by for-profit developers, which in turn improves the neighborhoods and the quality of life of residents.
2. **Operation SafeHouse- \$5,000** to support the *Main Street Transitional Living Program* which provides shelter for older homeless youth ages 18-22 for up to 24 months throughout Riverside County. Each youth is required to complete their GED/High School Equivalency, enter into continuing education or obtain a full time job, and save over half of their earnings to move on to permanent housing.
3. **The Debbie Chisholm Foundation - \$2,000** to support the "Cops 4 kids with Cancer" event which will benefit the "Spirit of Christmas Program". This program provides food and gifts for families who have a seriously ill child. This Christmas, The Debbie Chisholm Foundation, hopes to be able to assist more than 100 children.
4. **Honoring Our Fallen, Inc - \$5,000** to help support this program's effort to ensure that every soldier interned at Riverside National Cemetery has a United States Flag placed on their gravesite on Memorial Day and Veterans Day. There are approximately 225,000 veterans interned at Riverside National Cemetery
5. **Fire and Burn Foundation-\$1,000** to support the efforts of this foundation to reduce burn injuries and deaths through burn prevention education, burn survivor support programs and the funding of burn care research and treatment.
6. **RCRMC Foundation -\$2,500** to support the Festival of Trees Event which will help raise funds for specialized equipment at the Riverside County Regional Medical Center Foundation.
7. **Riverside Educational Enrichment Foundation- \$1,500** to support both the Riverside Educational Enrichment Foundation and the Alvord Educational Foundation on their mission to provide enrichment programs for over 63,000 students.
