BACKGROUND: The proposed assessments for Zones 1, 3, 8, 10, 11, 15, 19, 24, 26, 28, 29, 31, 36, 39, 43, 44, 45, 53, 55, 57, 58, 66, 68, 72, 74, 83, 84, 86, 87, 89, 91, 92, 94, 97, 100, 103, 109, 110, 112, 119, 123, 124, 135, 138, 145, 146, 148, 149, 152, 153, 154, 155, 157, 160, 161, 162, 164, 166, 168, 171, 172, and 174, and Street Lighting Zones 2, 3, 4, 9, 11, 12, 13, 14, 16, 20, 21, 22, 25, 29, 30, 31, 36, 37, 38, 42, 43, 44, 45, 46, 47, 48, 52, 53, 54, 55, 56, 57, 58, 61, 64, 65, 66, 67, 68, 72, 74, 75, 76, 78, 81, 82, 85, 89, 95, 97, 99, 101, 103, and 104 of L&LMD No. 89-1-C are described in Attachment A. The annual budget for fiscal year 2013-14 totals \$1,432,296.

Depending on the time the Zones were annexed into L&LMD No. 89-1-C, and the type of improvements, the mailed assessment ballot proposition approved by the property owners provides that either no inflation factor was established (Zones 1 and 3), a two percent (2%) inflation factor was established, or the annual assessment may be increased each year by the greater of two percent (2%) or the cumulative percentage increase, if any, in the Consumer Price Index (CPI-U), or the Consumer Price Index for electricity (CPI-U "for electricity") for the Los Angeles-Riverside-Orange County California Standard Metropolitan Statistical Area (the "Index") as the Index stands as of March of each calendar year.

For Fiscal Year 2013-14, the inflation factor, when appropriate, will be either two percent (2%) or thirteen point five percent (13.5%). Of 10,661 assessable parcels in L&LMD No. 89-1-C, there are 719 parcels within those Zones whose improvements are primarily the provision of electricity that may be affected by the thirteen point five percent (13.5%) increase. A majority of these parcels are assessed for streetlights and/or traffic signal lights where the major cost factor is electricity. Electricity costs increased in January 2013 by a documented 5%. It is expected that electricity costs will increase an additional 5-7% during fiscal year 2013-2014 as coastal generation decreases. The 13.5% increase will allow the L&LMD to absorb the existing 5% increase as well as the anticipated 5-7% increase expected in January 2014.

The inflation factor affects the maximum assessment, which is the maximum allowable assessment to be placed on a parcel, acre, or equivalent dwelling unit (EDU) within the L&LMD No. 89-1-C. Zones may be assessed at the maximum assessment if needed; however, some zones are assessed less depending on overall annual maintenance costs and existing reserves, if any.

18 **WHEREAS**, at the time and place of said public hearing, as set forth in Resolution No. 2013-152, the
19 Board of Supervisors held the public hearing and afforded all interested persons an opportunity to testify
20 and be heard, and considered all oral statements and all written protests or communications made or filed
21 by any interested persons and at the conclusion of said hearing determined that a majority protest had not
22 been received; and

23 **WHEREAS**, the Board of Supervisors may proceed, pursuant to Section 22631 of the Streets and
24 Highways Code, to adopt a resolution confirming the diagram and assessment, either as originally
25 proposed, or as changed by it, and the adoption of such a resolution shall constitute the levy of an
26 assessment on all assessable lots and parcels of land within L&LMD No. 89-1-C for FY 2013-14.

BACKGROUND: Landscaping and Lighting Maintenance District No. 89-1-Consolidated (District) maintains and services 138 locations throughout Riverside County. The District contains 62 separate assessment zones and 54 street lighting assessment zones as described in Attachment A. The annual budget for fiscal year 2013-14 totals \$1,432,296.

Depending on the time the Zones were annexed into L&LMD No. 89-1-C, and the type of improvements, the mailed assessment ballot proposition approved by the property owners provides that either no inflation factor was established (Zones 1 and 3), a two percent (2%) inflation factor was established, or the annual assessment may be increased each year by the greater of two percent (2%) or the cumulative percentage increase, if any, in the Consumer Price Index (CPI-U), or the Consumer Price Index for electricity (CPI-U "for electricity"), for the Los Angeles-Riverside-Orange County California Standard Metropolitan Statistical Area (the "Index") as the Index stands as of March of each calendar year.

For Fiscal Year 2013-14 the inflation factor, when appropriate, will be either two percent (2%) or thirteen point five percent (13.5%). Of 10,661 assessable parcels in L&LMD No. 89-1-C there are 719 parcels, within those Zones whose improvements are primarily the provision of electricity, that may be affected by the thirteen point five percent (13.5%) increase. A majority of these parcels are assessed for streetlights and/or traffic signal lights where the major cost factor is electricity. Electricity costs increased in January 2013 by a documented 5%. It is expected that Electricity costs will increase an additional 5-7% during fiscal year 2013-2014 as coastal generation decreases. The 13.5% increase will allow the LMD to absorb the existing 5% increase as well as the anticipated 5-7% increase expected in January 2014.

The inflation factor affects the maximum assessment, which is the maximum allowable assessment to be placed on a parcel, acre, or equivalent dwelling unit (EDU) within the L&LMD No. 89-1-C. Zones may be assessed at the maximum assessment if needed, however some zones are assessed less depending on overall annual maintenance costs and existing reserves, if any.

Consistent with the Board's direction regarding compliance with Article XIID of the California Constitution and the Landscaping and Lighting Act of 1972, the attached resolutions have been prepared and a public hearing scheduled for 9:30 a.m. on July 30, 2013 to receive testimony for and against the proposed assessments.

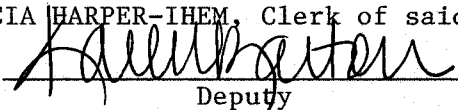

The actual rate property owners pay is based on the parcel size and there is 1 parcel.

Street Lighting Zone 72 was established 6 years ago with an assessment of \$94.30 per acre per year. The proposed budget for fiscal year 2013-14 is \$422.
