BACKGROUND: The Board of Supervisors adopted Riverside County Ordinance No. 525.5 effective April 16, 1998. Section 2 of the Ordinance established a five (5) member Board of Examiners, appointed by the Board of Supervisors. The members are appointed for three (3) year terms, not to exceed a collective appointment of ten (10) years.
