**SUBJECT:** Receive and File Peggy Robbins Award for Excellence in Neighborhood Redevelopment

**RECOMMENDED MOTION:** That the Board of Supervisors receive and file the Peggy Robbins Award for Excellence in Neighborhood Redevelopment.

**BACKGROUND:** In recognition for its Neighborhood Stabilization Program (NSP), the County of Riverside Economic Development Agency will be honored on September 17, 2013, with the Peggy Robbins Award for Excellence in Neighborhood Redevelopment at the 22<sup>nd</sup> Anniversary of Neighborhood Partnership Housing Services (NPHS), a nonprofit affordable housing developer. The award is in honor of a Montclair, California native for her work in community development and outstanding civic involvement. As a top performer among 307 grantees nationwide, the County of Riverside will be recognized as a leader in revitalizing and stabilizing neighborhoods that have suffered from foreclosures while creating affordable and sustainable homeownership opportunities. To date, 274 homes have been purchased, rehabilitated and sold to families generating over \$40 million in program income.
