Treasurer's Pooled Investment Fund

"Revising the Revisions"

Early on in my career as a financial consultant in the private sector as well as during my tenure here with the County Treasurer-Tax Collector's office executing investments for the TPIF, I always eagerly awaited, sometimes with trepidation, the monthly and quarterly economic numbers.

Two of the numbers that play a prominent role in the financial markets and in the overall health of the economy are GDP (gross domestic product) and unemployment. GDP, the monetary value of all finished goods and services produced within a country is calculated on an annual basis and reported quarterly. It includes all private and public consumption, government spending, investments and exports. The other economic indicator is the unemployment rate which is a number measured by the U.S. Bureau of Labor Statistics; they measure employment and unemployment, using two different labor force surveys. Both numbers are widely viewed as barometers of the overall health of the economy.

At first glance, the initial release of the first estimate for GDP for Q2 2013 was a surprise to the upside at 1.7%, significantly higher than the 1% estimate. This followed Q1 of 1.8% that was swiftly revised downwards to 1.1%. Now this would not be all that shocking except for the fact that the U.S. Government revised all GDP numbers going back to 1929 making it the single largest set of revisions in the history of the Bureau of Economic Analysis.

Other revisions we have seen recently are changes to the unemployment rate. Total nonfarm payroll employment (NFP) increased by 162,000 in July, and the unemployment rate dropped down to 7.4%. The change in

total NFP in May was revised from 195,000 to 176,000 and from 195,000 to 188,000 for June. With these revisions, employment gains for May and June were 26,000 less than previously reported. Moreover, the unemployment rate dropped in part because 37,000 workers dropped out of the work force, indicating they gave up looking for work. The labor force participation rate, which measures the percentage of Americans who are working or looking for work, fell to a near 35-year low in July. The civilian employment-population ratio, which measures how many Americans actually have jobs, was flat at 58.7%, its lowest in 30 years and down from more than 63% percent before the recession.

Fed Chairman Bernanke recently stated, "The official U.S. unemployment rate could mask the real problems in the labor market." Whether it's convenient timing, or that investors just don't have enough information yet to justify modifying the numbers suggests it will be tougher for the FED and investors alike in separating the wheat from the chaff when making important investment decisions for the future.

The FED left some room in their statement from the regularly scheduled meeting on July 31st that they could begin tapering off purchases of Treasury securities in the open market at any time between now and next year; they also left the benchmark rate unchanged at 0-.25%. Meanwhile the TPIF remains ready to take full advantage of any moves they make.



US Treasury Curve (M/M)




TIMMI

The Treasurer's Institutional Money Market Index (TIMMI) is compiled and reported by the Riverside County Treasurer's Capital Markets division. It is a composite index derived from five AAA rated prime institutional money market funds. Similar to the Treasurer's Office, prime money market funds invest in a diversified portfolio of U.S. dollar denominated money market instruments including U.S. Treasuries, government agencies, commercial paper, certificates of deposits, repurchase agreements, etc. TIMMI is currently comprised of the five multi billion dollar funds listed below.





SCHEDULED PAR %


