Between Jan 1, 20012 – Dec. 31, 2012, 454 children from the Fourth District were removed from their home due to abuse and neglect and placed in Foster Care. YMCA provides childcare services to families with limited financial means. Honoring Our Fallen, Inc. will help provide flags for our fallen soldiers at the Riverside National Cemetery.
