BACKGROUND: On September 18, 2007, agenda item no. 3.46, the Board of Supervisors approved an agreement with Loma Linda University Health Care, Department of Ophthalmology to provide professional services for the Hospital.

BACKGROUND:

This amendment adds additional retina physician clinical and surgical services coverage as a result of an increasing demand for this specialized ophthalmology service in the Hospital's outpatient clinics.

The Amendment has been reviewed and approved as to form by County Counsel.

**FOURTH AMENDMENT
TO THE
AGREEMENT
BETWEEN
COUTY OF RIVERSIDE
AND
LOMA LINDA UNIVERSITY HEALTHCARE**

That certain Agreement between the County of Riverside (COUNTY), a political subdivision of the State of California, on behalf of the Riverside County Regional Medical Center (HOSPITAL) and Loma Linda University Healthcare dated April 1, 2007 and amended effective April 1, 2007, February 1, 2011 and June 1, 2011 is hereby further amended effective July 1, 2013, pursuant to the following:

1. Delete Section 2.2 A in its entirety and replace with the following:

"A. Provide adequate staffing to assume medical care responsibilities as described herein, for general ophthalmology, ophthalmology specialty care, and retina subspecialty services under the direction of the Chief of the HOSPITAL Department of Surgery (DEPARTMENT) and the HOSPITAL Medical Director. This shall include ensuring there are adequate numbers of qualified general ophthalmology, specialty ophthalmology and retina subspecialty physicians, including an ophthalmology photographer on-site at hospital to provide general and specialty care and subspecialty ophthalmology outpatient services at the HOSPITAL for five (5) full-day clinics per week to include additional time for diagnostic procedures, inpatient and outpatient ophthalmology surgical services, consultation on a daily basis and on-call availability as specified in Section 2.6 of the Agreement.

In addition to the services described above, CONTRACTOR agrees to provide the professional services of a Retina Fellow for five (5) additional half-day outpatient retina clinics per week in the Ophthalmology clinic.

2. Delete Section 1.0, Exhibit A in its entirety and replace with the following:

"1.0 Subject to the conditions set forth below, HOSPITAL shall pay CONTRACTOR a total of five hundred twenty six thousand, two hundred thirty six dollars and forty cents (\$526,236.40) per year for the services of a minimum of 2.0 full time equivalent general ophthalmology, 0.5 full time equivalent retina subspecialist and 0.4 other

specialty ophthalmology physician(s) from the CONTRACTOR's Medical Group to provide general ophthalmology and specialty ophthalmology outpatient clinical services, inpatient and outpatient consultative care services, inpatient and outpatient surgical and subspecialty surgical ophthalmology services and development of treatment protocols for ophthalmology services provided at HOSPITAL.

HOSPITAL shall pay CONTRACTOR an additional forty-five thousand (\$45,000) dollars annually for a Retina Fellow to provide retinal services in the Ophthalmology clinic for two and a half day per week.

4. Delete Section 3.0 Exhibit A in its entirety and replace with the following:

"3.0 Maximum Annual Compensation

Maximum annual compensation payable under this Agreement shall not exceed six hundred fifty-six thousand, two hundred thirty-six dollars and forty cents (\$656,236.40) for administrative, supervisory, teaching and direct patient care professional services and an additional forty-five thousand dollars (\$45,000) for a retina fellow's professional services provided in the Hospital's outpatient clinics."

All other terms and conditions of this Agreement are to remain in full force and effect.
