District Board of Trustees believe this request is necessary for the following teasons: (1) The array of services that the residents are offered at the District would be better represented through a five member Board of Trustees because the population has grown to a much larger, more diverse demographic within the District's geographic boundary since formation; (2) The increase will help reduce the risk of any possible delayed issue resolutions that a three member Board might experience should two of those members be out sick or on vacation at the same time. This would result in the required quorum not being met prolonging any resolution of a resident's concerns or Policy and Procedure matters; (3) When the residents are represented properly by the Board of Trustees for any Special District, it quickly and efficiently builds the confidence and trust of the residents living in that District; and (4) A five Member Board would also prevent any possible coercion among a three member board and insure that the specific responsibilities of the Board are being established and supporting the structure of the District.

WHEREAS, on July 10, 2013, the Board of Trustees approved a resolution seeking to increase in the number of seats on the Board of Trustees from three (3) trustees to five (5) and directed that the resolution approving the increase be submitted to the Board of Supervisors; and

WHEREAS, a copy of the Elsinore Valley Cemetery District Board of Trustees Resolution 13-07 1 was submitted to the Board of Supervisors on August 20, 2013 with Board of Supervisors Resolution No. 2013-216; and

WHEREAS, Health and Safety Code section 9025 (b) states that within 60 days of receiving the board of trustees' resolution adopted pursuant to subdivision (a), the Board of Supervisors must consider the resolution at a noticed public hearing; and

WHEREAS, on August 20, 2013 in Resolution No 2013- 216 the Board of Supervisors scheduled a public hearing for September 10, 2013 and directed the Clerk of the Board to provide published notice in accordance with Health and Safety Code section 9025 (b) and Government Code section 6061; and

WHEREAS, the Board of Trustees of the Elsinore Valley Cemetery District believes an increase in the number of trustees is necessary for the following reasons: (1) The array of services that the residents are offered at the District would be better represented through a five member Board of Trustees because the population has grown to a much larger, more diverse demographic within the District's geographic
