



BACKGROUND:

The Red Hot Ballroom is collaborating with the three local school districts to provide students the opportunity to participate in dance instruction. This program is intended to build self-esteem and will help students with special needs engage in a fun recreational activity.

The 21st District Legionnaire District produces the Legionnaire Newspaper that provides readers with up to date information regarding Post activities, along with vital Veterans issues and legislation, and information regarding special events.

CSUSB, Palm Desert Campus will be hosting a symposium, "Sustainable Goods Movement: Maintaining the Environment, Economy and Equity" on November 21st and 22nd. The purpose of the two day event is to advance and broaden our understanding of the scientific, social and economic aspect of goods movement, with a central focus of addressing concerns and proposing solutions for long-term sustainability.

Community Connect provides 24 hour, 7 days a week list of resources for residents seeking information about health and human services, housing, education, and other essential programs.

The General Patton Museum will be hosting the 25th Anniversary of the General Patton Memorial Museum on November 11 in Chiriaco Summit.

The Foundation on Aging will be providing gift cards to seniors who have financial need. They will work with the local senior centers to identify seniors that qualify.
