**ORDINANCE NO. 671.20**

**AN ORDINANCE OF THE COUNTY OF RIVERSIDE  
AMENDING ORDINANCE NO. 671 ESTABLISHING CONSOLIDATED FEES FOR  
LAND USE AND RELATED FUNCTIONS**

The Board of Supervisors of the County of Riverside ordains as follows:

Section 1. Section 10. of Ordinance No. 671 is amended to read as follows:

"Section 10. Ordinance No. 578 Fees. The fees for Ordinance No. 578, providing for the establishment of historic preservation districts shall be as follows:

	Deposit-based Fee:
1. Historic District Alteration Permit	
a. General Fund	
i. Planning Department	216
ii. Transportation Department-Comprehensive	16
Transportation Plan	
b. Parks District	473.*

Section 2. This ordinance shall take effect thirty (30) days after its adoption.
