**SUBJECT:** Approval of the Amendment to Professional Services Agreement between DPSS and Family Service Association (FSA) for the Child Abuse Prevention Council [\$568,023]

**RECOMMENDED MOTION:** That the Board of Supervisors:

1. Designate FSA as the County's Children's Trust Fund Council in accordance with Welfare and Institutions Code Sections 18968 through 18970;
2. Approve and authorize the Chair of the Board to sign the attached Amendment # CS-02713-01 with Family Service Association (FSA) for the period of November 1, 2013 through June 30, 2014 for \$468,023 with the option to renew for three (3) additional one-year periods for an amount not to exceed \$568,023.
3. Authorize the Director of the Department of Public Social Services (DPSS) to administer the contract.
4. Authorize the Purchasing Agent, in accordance with Ordinance No. 459, to exercise renewal options, based on the availability of fiscal funding, and to sign amendments that do not change the substantive terms of the agreement, including amendments to the compensation provision that do not exceed the annual CPI rates.

**BACKGROUND:**  
**Summary (continued)**

Per Welfare and Institutions Code Section 18965 through 19070, the County Board of Supervisors may approve and designate a local agency as a lead agency in Riverside County for coordinating regional child abuse prevention and intervention services and provide oversight for the Children's Trust Fund.

In order to ensure transition of councils, County Purchasing executed a contract with FSA in the amount of \$100,000 to cover transition activities from July 1, 2013 through October 31, 2014. This amendment will allow for DPSS Children's Services Division to continue work with FSA on child abuse issues in Riverside County through the fiscal year, and subsequent renewal years. FSA will provide services in Riverside County for coordinating regional child abuse prevention and intervention services and provide oversight of the Children's Trust Fund Council. FSA will work with, and provide support for, existing collaborative members to foster community involvement in a geographically specific manner. FSA has set aside \$60,000 to provide financial support to the regional collaboratives.

Additionally, FSA will provide public outreach and sponsor events highlighting the recognition and prevention of child abuse and neglect as well as hold Mandated Reporter Trainings through the County. FSA will assist with the County's Community Partners Forum, which is held bi-annually to inform the community about child abuse prevention goals and outcomes.

FSA proposes to maximize funding by providing an in-kind match in the amount of \$270,970.00 for FY 13/14 (33 1/3% of total contract amount for all years). FSA is actively pursuing grant opportunities to enhance their proposed contract services.

DPSS requests that the Board of Supervisors approve the amendment with FSA to align with the requirements of the Welfare and Institutions Code.

**Impact on Citizens and Businesses**

Pursuant to W&IC 18967, money in the children's trust fund of each county shall be used to fund child abuse and neglect prevention and intervention programs.

**Contract History and Price Reasonableness**

At the Board of Supervisor's request, an RFP was released by DPSS through Riverside County Purchasing and Fleet Services, to obtain these services for Fiscal Years 2013/2014 through 2016/2017. The funding recommendation to award Family Service Association the RFP for the Child Abuse Prevention Council was granted Board of Supervisor Approval on 5/21/13 (Ref. 3.14).

If additional collaboratives are needed, FSA shall work with DPSS to identify and create those collaboratives."
5. Amend Section IV. Contractor Responsibilities, Subsection C. Fiscal, 1. Maximum Reimbursable Amount to read:  
"Total payment under this Contract shall not exceed \$ 468,023.00"


