BACKGROUND:

Summary

On October 16, 2012 the Board approved agenda item 3.35a, containing the PSEC Business Plan and PSEC Service rates for FY 13/14. The new PSEC Service rates replaced the legacy radio system service rates. Due to PSEC project delays, the approved FY 13/14 PSEC service rates could not be utilized to invoice County Departments. Since the PSEC project delay was not anticipated, service rates for the legacy system needed to be developed until the new system is fully operational.

BACKGROUND:

Summary (continued)

The Sheriff Department is the primary user of the legacy radio system. RCIT, in conjunction with the PSEC Steering Committee developed legacy service rates (EDAC rates) based on the twenty-seven sites supporting the legacy radio system. Attachment A represents the revised Rate Guide for FY 13/14 to include the legacy rate for both mobile and portable radios. The previously Board approved PSEC subscriber rates for the new system is \$37.96 - \$217.83. The proposed legacy mobile and portable subscriber rate is \$23.45 - \$153.06. Upon full implementation of the PSEC System the approved PSEC subscriber rates will take effect. The fiscal impact to the Sheriff is approximately \$4.9M for seven months. The approximate fiscal impact to Fire is \$64K for seven months.

The Rate Guide also reflects a modification to the High Performance Data (HPD) Modem rate that will allow scalability based on usage – an important issue to agencies looking to utilize the county's radio system. A rate for a Radio Technician was added to the table.

Impact on Citizens and Businesses

The new public safety radio system expands radio coverage and builds radio links to other agencies that will help protect our emergency first responders and the public they serve.

SUPPLEMENTAL:

Additional Fiscal Information

Presently, the RCIT Critical Communication Solutions Division (COM) is operating at a deficit as billing for the legacy system has not occurred. The PSEC System was expected to be in service by June of 2013. Due to unanticipated project delays RCIT could not collect revenue using the approved rates while the Sheriff continued to use the legacy radio system. The legacy mobile and portable subscriber rate will be retroactive to July 1, 2013.
