BACKGROUND:

Summary

Government Code Section 16304.3 requires local jurisdictions to formally request extensions for projects where funds are not fully expended within the life of the appropriation. The State Department of Transportation is also mandating that requests for extension include Board of Supervisors (Board) approval, indicating concurrence with the Transportation Department's extension request.

Summary (continued)

The State initially allows six or seven fiscal years for expenditure of federal funds authorized to projects. One-year time extensions may be requested until a maximum availability of eight years is reached.

This one-year time extension request is for funds having an expenditure deadline of June 30, 2014. Caltrans is advising that a time extension be sought for all funds, which may not be invoiced by December 31, 2013.

Federal funds for construction of the Palm Drive/Gene Autry Trail Interchange Project were authorized in FY 2008/2009, and the current unexpended balance is \$247,896. There are a few construction items needing to be addressed to receive Caltrans sign-off of construction completion. The project close-out documentation and final invoice process will follow. This process will not be finished prior to December 31, 2013, and a time extension is needed.

The Director of Transportation has transmitted the attached time extension request documents to Caltrans in order to meet their response deadline. Board action is necessary for Caltrans to grant approval of the time extension requests.


