Summary

By Minute Order dated July 30, 2013 (Agenda Item 3-62), the Board of Supervisors authorized the Clerk of the Board to advertise for the construction of East Hemet Resurfacing Project in the communities of East Hemet and Valle Vista. Bids were opened on August 21, 2013, for the resurfacing of thirty streets. The lowest responsible bid was submitted by All American Asphalt of Corona, CA in the amount of \$1,613,608.

Five bids were received ranging from \$1,649,188 to \$2,161,313. The basis for the selection of a contractor is the lowest responsive and responsible bid. The lowest responsive and responsible bid was submitted by All American Asphalt of Corona, CA in the amount of \$1,613,608, which is \$50,812 (3.0%) less than the Engineer's Estimate.

The bid includes one base bid schedule and one alternate bid schedule. The alternate bid schedule, designated for the contractor to do a Lake Hemet Municipal Water District (LHMWD) construction item, is not selected for award. The LHMWD will do manhole adjustment work with their own forces as needed. Even though this alternate bid is not selected for award, funds from LHMWD will contribute for resurfacing costs in lieu of utility trench overlay. The Transportation Department recommends award of the base bid schedule and not award the alternate bid schedule of work; therefore, the total Contract amount is \$1,613,608. The construction duration for this project is 40 calendar days.

The contractor is qualified to perform the work as outlined in the bid, has executed the Contract, and has provided bonds and insurance documents, which meet the requirements of the Contract.

Impact on Citizens and Businesses

The streets included in this project are residential and are listed on Attachment 1.

The existing pavement will be removed and new pavement will be placed. In addition, curbs and gutters that are in poor condition will be replaced, and any existing access ramps that do not meet the current Americans with Disabilities Act (ADA) requirements will be improved or replaced to meet the current requirements. Several new access ramps will also be added.

SUPPLEMENTAL:

Additional Fiscal Information

The Contract will be awarded to All American Asphalt for the total amount of \$1,613,608. The East Hemet Resurfacing Project is funded with Proposition 1B (State Bond Funds - Local Roads), Gas Tax, Measure A/Western Funds and funds from LHMWD in lieu of utility trench overlay. There are no General Funds used in this project. See Attachment "A" for project cost and funding information.

Contract

THIS CONTRACT is entered into at Riverside, California as of the date set forth below is between County of Riverside hereafter called "County" and All American Asphalt, hereafter called "Contractor".

WITNESSETH

Recitals:

1. Contractor has submitted to County his Contractor's Proposal for the construction of County Project, **East Hemet, Resurfacing Project, In the Community of East Hemet and Valle Vista, Project No. C3-0052, C3-0053 and X-1108**, in strict accordance with the Contract Documents identified below and County has accepted said Proposal.
2. Contractor states that he has reexamined his Contractor's Proposal and found it to be correct, has ascertained that his subcontractors are properly licensed and possess the requisite skill and forces, has reexamined the site and Contract Documents and is of the opinion that he can presently do the work in accordance with the Contract Documents for the money set forth in his Proposal to be paid as provided in the Contract Documents.

Agreement:

It is agreed by the parties as follows:

1. Contract Documents

The entire Contract consists of the following: (a) The Construction Contract, (b) The Notice Inviting Bids, (c) The Instruction to Bidders, (d) The Bid, (e) The Bid Bond, (f) The Payment Bond, (g) The Performance Bond, (h) The General Conditions, (i) The Special Provisions, (j) The Standard Specifications of the State of California Department of Transportation edition of May 2006 as modified in other portions of the Contract Documents and as amended by the State of California Department of Transportation, (k) The Standard Plans of the Department of Transportation identified on the plans or in the Special Provisions, (l) The Plans, (m) Addenda **(none)**, (n) The Determination of Prevailing Wage Rates for Public Work, (o) Any Change Orders issued, (p) Any additional or supplemental specifications, notice, instructions and drawings issued in accordance with the provisions of the Contract Documents. All of said Documents presently in existence are by this reference incorporated herein with like effect as if here set forth in full and upon the proper issuance of other documents they shall likewise be deemed incorporated. The Bid Bond is exonerated upon execution of this Contract and the Payment Bond and Performance Bond.

2. The Work

Contractor shall do all tasks necessary to construct the work generally described in Recital No. 1 in accordance with the Contract Documents.

3. Liquidated Damages and Time of Completion

Attention is directed to the provisions in Section 8-1.06, "Time of Completion", and in Section 8-1.07 "Liquidated Damages", of the Standard Specifications and these Special Provisions.

Standard Specification Section 8-1.03, "Beginning of Work" is modified to read as follows:

The Contractor shall begin work within five (5) calendar days, or as revised in the Special Provisions, of the date stated within the written "Notice to Proceed".

The Contractor shall notify the Engineer, in writing, of the Contractor's intent to begin work at least 72 hours before work is begun. If the project has more than one (1) location of work, Contractor shall submit a separate notice for each location. The notice shall be delivered to the Transportation Department's Construction Engineer and shall specify the date the Contractor intends to start at said location.

Should the Contractor begin work in advance of receiving a written "Notice to Proceed", any work performed by the Contractor in advance of the date stated in the "Notice to Proceed" shall be considered as having been done by the Contractor at his own risk and as a volunteer and subject to the following:

- A. The Contractor shall, on commencing operations, take all precautions required for public safety and shall observe all the provisions in the Specifications and the Special Provisions.
- B. All work done according to the contract, prior to the issuance of the "Notice to Proceed", will be considered authorized work and will be paid for as provided in the contract.
- C. The Contractor shall not be entitled to any additional compensation or an extension of time for any delay, hindrance or interference caused by or attributable to commencement of work prior to the issuance of the "Notice to Proceed".

4. Compensation

Contractor shall be paid in the manner set forth in the Contract Documents the amount of his Proposal as accepted by County, the above rates, subject to additions and deductions as provided in the Contract Documents. Said Proposal is on file in the Office of the Clerk of the Board of Supervisors of County.
