ORDINANCE NO. 452.234

AN ORDINANCE OF THE COUNTY OF RIVERSIDE AMENDING ORDINANCE NO. 452 RELATING TO PRIMA FACIE SPEED LIMITS

The Board of Supervisors of the County of Riverside ordains as follows:

Section 1. Section 2.3 of Ordinance No. 452, entitled Thirty-Five miles per hour, is hereby amended to add new subsections 117 and 118 to read as follows:

117. On Briggs Road between Barn Road and Thorens Road, a total distance of approximately 0.75 miles, in the Murrieta area.

118. On Dale Kiler Road between 7th Street and a point 2.860 north of 7th Street, a total distance of approximately 0.75 miles, in the Murrieta area.

Section 2. Section 2.4 of Ordinance No. 452, entitled

Street, a total distance of approximately 0.54 miles, in the Mecca area."

Section 2. Section 2.4 of Ordinance No. 452, entitled Forty miles per hour; is hereby amended to add new subsections 137, 138, and 139 to read as follows:

137. On El Chimisal Road between a point 330' east of Redhawk Parkway and Anza Road, a total distance of approximately 0.6 miles, in the Temecula area.

138. On Morgan Hill Drive between Villa Helena Street and a point 260' north of Coppola Street, a total distance of approximately 0.3 miles, in the Temecula area.

139. On Wisteria Loop between Pourroy Road (south) and Pourroy Road (south) and Pourroy Road (north), a total distance of approximately 1.1 miles, in the Murrieta area.

Section 3. Section 2.5 of Ordinance No. 452, entitled "Forty-Five miles per hour," is hereby amended to add new subsections 155, 156, and 157 to read as follows:

"155. On Briggs Road between Thorens Road and Leon Road, a total distance of approximately 0.31 miles, in the Murrieta area.

156. On Max Gilliss Boulevard between Leon Road and Winchester Road, a total distance of approximately 0.43 miles, in the Murrieta area.

157. On Orange Avenue between Brown Street and Old Elsinore Road, a total distance of approximately 0.43 miles, in the Murrieta area.

158. On Orange Avenue between Brown Street and Old Elsinore Road, a total distance of approximately 0.4 miles, in the Perris area.

Section 4. This ordinance shall take effect 30 days after its adoption.
