BACKGROUND:

Summary

The Larry D. Smith Correctional Facility third expansion was financed through the Tobacco Securitization Fund. Due to leaks in the showers in three of the housing units that leaked into the walls and floors, they were in need of repair. On April 9, 2013, the Board of Supervisors approved the Shower Repairs at the Larry D. Smith Correctional facility (M.O. 3-17). This project was to repair 36 showers by removing both the existing floor and epoxy coating, and install new floors and epoxy coating throughout the showers from floor to ceiling.

On October 16, 2012, the Board of Supervisors approved the construction agreement for Job Order Contract No. 005 between the County of Riverside and De La Riva Construction, Inc. Pursuant to the contract, two job orders were issued for the Sheriff's Department in support of the Larry D. Smith Correctional Facility Shower Repair project in the combined amount of \$523,625.

The project has been inspected and found to comply with all contract requirements. This Board action will release the contract retention funds of \$26,181 to De La Riva Construction, Inc. The contract retention funds are within the overall project budget and no additional funding is required.

Impact on Residents and Businesses

Recording the Notice of Completion for De La Riva Construction, Inc., will not impact residents and businesses.

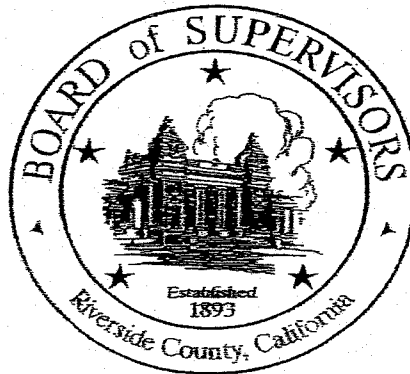
