BACKGROUND:

Summary

The Riverside Centre HVAC project was funded through the Energy Efficient Conservation Block Grant (EECBG). Due to the age of the equipment, frequent breakdowns and high energy operation costs, the air handlers for the supply and return air was in need of replacement. This project replaced all motors and fans, installed variable frequency drives to control the motors which operate through the building automation system for the reduction of energy costs.

On October 16, 2012, the Board of Supervisors approved the construction agreement for Job Order Contract No. 005 between the County of Riverside and De La Riva Construction, Inc. Pursuant to the contract, one job order was issued for the Riverside Centre HVAC Upgrade project in the amount of \$205,890.

The project is now complete and has been inspected and found to comply with all contract requirements. This Board action will release the contract retention funds of \$10,294 to De La Riva Construction, Inc. The contract retention funds are within the overall project budget and no additional funding is required.

Impact on Residents and Businesses

The Riverside Centre HVAC project had no impact on residents and businesses.
