BACKGROUND: Summary

On October 21, 2008, Agenda Item 9.1, the Board approved the issuance of the 2008 Series A Certificates of Participation (Capital Improvement Projects) which financed various desert capital projects including those listed on Attachment A. The original allocation of bond proceeds was based on the estimated project budgets known at the time of issuance. With the listed actual projects now complete. additional fund balances remain that can be allocated to another capital project.

BACKGROUND: Summary (continued)

The cost for the Mecca Street Improvement/99 Cent Store Repair Project is \$100,000. The Mesa Verde Community Center and the North Shore Yacht Club projects were funded by the 2008 Series A Certificates of Participation bond proceeds, and have remaining balances of \$25,000 and \$79,000 respectively. Staff recommends the reallocation of \$25,000 from the Mesa Verde Community Center project, and \$75,000 from the North Shore Yacht Club project to fund the proposed capital improvements.

Impact on Citizens and Businesses

The Mecca Street Revitalization Project, Phase 1 is benefitting the community of Mecca by providing sidewalks, curb, and gutters that enhance pedestrian access and improve street drainage. The repair of the Mecca 99 Cent Store will enhance the community by removing the blighted appearance of the store façade caused by removal of the awning.
