SUBJECT: Approval of LPS (5150) Designation of Corona Regional Medical Center for Involuntary Detention of Mentally Disordered Persons for Evaluation and Treatment (District: All) [\$0]

RECOMMENDED MOTION: That the Board of Supervisors:

1. Designate Corona Regional Medical Center (CRMC), a 237-bed facility located at 800 S. Main Street, Corona, CA 92882, as a facility for 72-hour treatment and evaluation pursuant to California Welfare and Institutions Code, Section 5150 et. Seq.; and
2. Authorize the Director of Mental Health to submit the request to the State Department of Health Care Services as required by Section 800 et. Seq., Title 9, California Code of Regulations.

BACKGROUND:

Summary

Pursuant to the California Welfare and Institutions Code, Section 5150, the Riverside County Department of Mental Health is requesting that the Board of Supervisors designate CRMC's 237-bed hospital as a facility for medical clearance and subsequent involuntary detention of mentally disordered persons for evaluation and treatment under the general acute care license of CRMC.

Impact on Citizens and Businesses

The designation of CRMC's hospital will provide an Emergency Department and hospital to medically clear clients that have been placed on a 5150 involuntary hold, and will provide thirty-seven (37) additional acute hospitalization beds for County of Riverside constituents with severe mental illness, who require a 5150 designated facility for continued medical care and mental health treatment. These services are a component of the Department's system of care aimed at improving the health and safety of consumers and the community.
