Summary

Pursuant to the California Welfate and Institutions Code, Section 5150, the Riverside County Department of Mental Health is requesting that the Board of Supervisors designate CRMC's 237-bed hospital as a facility for medical clearance and subsequent involuntary detention of mentally disordered persons for evaluation and treatment under the general acute care license of CRMC.
