**Summary**

The Fourth Amendment to the agreement with RadNet Management, Inc. assigns all of the rights and responsibilities from RadNet Management to Beverly Radiology Medical Group. Beverly Radiology has agreed to continue to provide Positron Emission Tomography (PET) Imaging services for the Hospital's patients at the same rates of reimbursement.

**Impact on Citizens and Businesses**

This service impacts the hospital's patients residing in Riverside County receiving care from Riverside County Regional Medical Center that are the financial responsibility of the County. PET services are not available on-site at the Hospital and are a valuable tool in the diagnosis, staging and treatment of cancer. Beverly Radiology Medical Group has multiple locations in Riverside and San Bernardino County providing this health care service.

**Additional Fiscal Information**

There is no increase in cost for the Hospital with the assignment of this agreement to Beverly Radiology Medical Group.

**Contract History and Price Reasonableness**

PET diagnostic services are contracted for payment at Medicare Allowable case rates. All other radiology diagnostic services are contracted for 100% Medi-Cal rates of reimbursement.

That certain Agreement between the County of Riverside (COUNTY), a political subdivision of the State of California, on behalf of the Riverside County Regional Medical Center (HOSPITAL) and RadNet Management, Inc., dated November 1, 2004 amended on July 1, 2009 and October 1, 2009 is hereby further amended effective January 1, 2013 pursuant to the following:

1. **13.0 ASSIGNMENT:**

“Effective on the Effective Date noted above, Assignor (CONTRACTOR) hereby transfers, assigns, conveys, grants, and sets over to Assignee (CORPORATION) all its rights, title and interest in to the Agreement.

Assignee (CORPORATION) hereby accepts assignment granted herein, and assumes and agrees to perform and to keep all covenants and agreements of Assignor (CONTRACTOR) under the Agreement. Assignee (CORPORATION) agrees that the COUNTY shall be entitled to enforce against Assignee (CORPORATION) every term, covenant, and obligation under the Agreement in respect of the period for the term thereof from and after the Effective Date hereof with the same force and effect as though Assignee (CORPORATION) was named therein.”

2. Delete Section 19.0 of this Agreement in its entirety and replace as follows:
