BACKGROUND:

Summary

The amendment revises language related to professional services provided in the emergency department. All Dermatology issues identified in the emergency department are referred to the outpatient clinics for consultation and treatment.

Contract History and Price Reasonableness

On January 10, 2012, agenda item no. 3.47 the Board approved the contract agreement with Faculty Physicians and Surgeons of Loma Linda School of Medicine, without securing competitive bids, in accordance with Ordinance 459.4 effective December 1, 2011 for an aggregate amount not to exceed \$352,000 annually. There is no increase to the costs of dermatology services for the County with this amendment.

**FIRST AMENDMENT
TO THE
AGREEMENT BETWEEN
COUNTY OF RIVERSIDE
AND
FACULTY PHYSICIANS AND SURGEONS OF LOMA LINDA SCHOOL OF MEDICINE**

That certain Agreement between the County of Riverside (COUNTY), a political subdivision of the State of California on behalf of the Riverside County Regional Medical Center (HOSPITAL) and Faculty Physicians and Surgeons of Loma Linda University School of Medicine (CONTRACTOR), is hereby amended ratified to December 1, 2011 pursuant to the following:

1. Delete Section 3.2.4 A. and replace with the following:

"A. Assist to establish rules and regulations, development of treatment protocols for the operation of Dermatology services with its appropriate areas including, but not limited to, Ambulatory Care Dermatology Clinics, Outpatient Consultative Services, inpatient consultative services and operating room procedures."

All other terms and conditions of this Agreement are to remain in full force and effect.
