Summary (continued)

On May 8, 2012, the Board of Supervisors adopted the 2012-2013 One-Year Action Plan of the County of Riverside's 2009-2014 Five-Year Consolidated Plan for the HUD-funded Community Planning and Development Programs. On September 27, 2013, pursuant to 24 C.F.R. § 91.520, the County prepared and submitted to HUD the Consolidated Annual Performance and Evaluation Report (CAPER) for the County of Riverside's Department of Housing and Urban Development CPD-funded programs for the reporting period July 1, 2012, through June 30, 2013. The CAPER represents a comprehensive and consolidated year-end report of the County's use of CDBG, ESG, and HOME Programs. The CAPER also provides a narrative summary of the performance and accomplishments during the 2012-2013 Program Year, including, but not limited to an evaluation of the performance and accomplishments of the Five-Year 2009-2014 Consolidated Plan.

Impact on Residents and Businesses

The County expended \$8,966,214 in CPD program funding, excluding Program Income (PI), during the 2012-2013 program year. The total expenditures included \$6,587,438 of CDBG funds including Lake Elsinore (Metro City); \$1,867,001 in HOME funds; and \$511,775 in ESG funds.
