BACKGROUND:

Summary

The Calimesa Channel project consists of the construction and subsequent operation and maintenance of a concrete rectangular channel, which was originally constructed in 1971. At this time the areas needed in order to maintain and operate the facilities were secured by fencing. However, the entire parcels that were acquired were not contained within this fencing. Over the years, the adjacent properties have assimilated these parcels within their boundaries and now these are rear, front and side yards.

BACKGROUND:

Summary (continued)

In order to remedy these encroachments, staff is requesting these parcels to be declared surplus because the parcels are no longer needed for District purposes and authorize staff to negotiate with the adjacent property owners for the conveyance of these parcels to them. The sale of these parcels will remove both a maintenance and potential liability problem for the District and will also place these parcels back onto the tax rolls. After negotiations have been finalized, the individual agreements for the disposition of these parcels will be brought to the Board for approval.

Pursuant to California Surplus Lands Act (Government Code Section 54220 et seq) and prior to disposing of any real property declared as surplus, a local agency shall send written offers to sell the property to other public agencies who may be interested in acquiring such surplus real property unless it is deemed exempt from this requirement. Surplus property as such are defined in California Government Code Section 54221 is exempt from this requirement and may be disposed of without sending out any written offers to sell to other public agencies. The District-owned parcels, listed on Attachment A, consists of parcels varying in size from approximately six (6) square feet of land to 6,545 square feet of land (Exempt Property), are irregular in shape, have no legal access for ingress or egress, are remnant parcels with very low values, are zoned Residential High, Residential Low Medium, Commercial Community and Commercial Neighborhood have been encroached upon by the adjacent property owners. As a result, the District is not required to send written offers to other public agencies and may proceed with disposing of this real property. The District may dispose of real property of every kind within or without the District necessary and convenient to the full exercise of its powers after adoption of a resolution declaring that a real property interest is no longer necessary to be retained for District uses or purposes pursuant to California Water Code Appendix Sections 48-9 and 48-13. This Exempt Property is no longer necessary to be retained for the Calimesa Channel or any District uses or purposes; therefore, staff is recommending the adoption of Resolution No. F2013-33 to declare these parcels surplus and dispose of the Exempt Property.

Resolution No. F2013-33 has been approved as to form by County Counsel.

WHEREAS, the Riverside County Flood Control and Water Conservation District (District) is the owner of certain real property, consisting of several parcels, listed on Attachment A, attached hereto and made a part hereof, varying in size from approximately six (6) square feet of land to 6,545 square feet of land, located in the city of Calimesa, County of Riverside, (Exempt Property); and

WHEREAS, pursuant to the California Surplus Lands Act (the "Act", Government Code Section 54220, et seq.) any real property declared as surplus is exempt from the requirements of the Act if such real property is: i) less than 5,000 square feet in area; or ii) less than the minimum legal residential building lot size for the jurisdiction in which the parcel is located, or 5,000 square feet in area, whichever is less; or iii) has no record access and is less than 10,000 square feet in area; and is not contiguous to land owned by a state or local agency that is used for park, recreational, open-space, or low- and moderate-income housing purposes and is located neither within an enterprise zone pursuant to the Government Code Section 7073 nor a designated program area as defined in Section 7082 of the Government Code; and

WHEREAS, if the surplus land that qualifies as exempt is not sold to an owner of contiguous land, then it is not considered exempt surplus land and is subject to requirements of the Act; and

WHEREAS, the District may proceed with the sale of this Exempt Property without first providing written offers to sell to other public agencies or housing sponsors; and

 15 herein, are no longer necessary to be retained by District for public purposes.
