BACKGROUND:

Summary (continued)

OES designs and conducts exercises for different scenarios and coordinates emergency management training to insure that OES is able to respond to natural, human caused and technological emergencies. The OES coordinates the interagency response for a wide range of emergencies including but not limited to earthquake, terrorism, wildfires, flooding, extreme heat and severe weather, utility outages, droughts, transportation accidents, hazardous materials releases, civil unrest.

On June 12, 2012, Agenda #3.24, the Board of Supervisors approved a professional services agreement with Willdan Home Solutions for Emergency Preparedness and Response Branch Emergency Operations Planning Project. On January 29, 2013, Agenda 3-23 the Board of Supervisors approved Amendment No. 2; increasing the contract amount by \$ 105,000 through January 31, 2014 for a Continuity of Operations (COOP)/Continuity of Government Plan for Riverside County using an all hazards approach from Multi-Jurisdictional Hazard Mitigation Plan. These projects have begun and the County along with Willdan Homeland Solutions needs additional time to complete the entire scope of the projects. The Fire Department is requesting an extension of the period of performance only.

Impact on Citizens and Businesses

Willdan will be providing consulting services to assist the Riverside County Operational Area to complete and finalize a GAP analysis that focuses on heavy emergency response equipment as well as identify resources for access and functional needs equipment to determine the response gaps throughout the County running the collected data through a series of Hazardous scenarios. Additionally, the contract for consulting services includes revising our Operational Area Emergency Operations Plan and the development of twenty-two (22) functional annexes to address the four stages of emergency management within the County. Templates for both the Emergency Operations Plan and annexes will be created for our cities' use. The Coop & Cog annex will also be developed into a full plan that will allow for the Continuity of Operations and Government that will help pre-identify resources and facilities to ensure that businesses and residents can maintain the highest level of services after a disaster or incident.

SUPPLEMENTAL:

Additional Fiscal Information

The Board action today will not increase the cost of this contract. The total contract amount is \$ 388,448 and is 100% funded by Homeland Security Grant funds. No County funds are required. The Department expended \$ 180,959 in FY 12/13 and estimates expending \$100,000 in FY 13/14 and \$ 107,489 in FY 14/15. The Department is only requesting an extension of time.

Contract History and Price Reasonableness

On February 9, 2012, the Riverside County Fire Purchasing Department released RFP #FPARC126 for Emergency Preparedness and Response Branch Emergency Operations Planning Project. Willdan Homeland Solutions was selected and a contract was approved by the Board of Supervisors on June 12, 2012, Agenda #3.24. On January 29, 2013, Agenda 3-23 the Board of Supervisors approved Amendment No. 1; increasing the contract amount by \$ 105,000 through January 31, 2014. The Department is requesting approval of Amendment No. 2 extending the period of performance only.

- 1. On page 3 of the Agreement, amend Section 2 the "Period of Performance": To amend all reference to the Period of Performance from expiration of December 31, 2013, to a Period of Performance of June 12, 2012 through December 30, 2014, unless terminated as specified in Section 5 TERMINATION. If due to scheduling concerns arising from the COUNTY availability, the period of performance may be extended to April 30, 2015, upon written request from the COUNTY. All other terms of the Period of Performance in the Agreement shall apply.
- 2. All other terms and conditions of the Agreement are to remain unchanged.
