ORDINANCE NO. 659.12 AN ORDINANCE OF THE COUNTY OF RIVERSIDE AMENDING ORDINANCE NO. 659 ESTABLISHING A DEVELOPMENT IMPACT FEE PROGRAM

The Board of Supervisors of the County of Riverside ordains as follows:

Section 1. Subsection a. of Section 13 of Ordinance No. 659 is amended to read as follows:

"a. The Director of the Transportation and Land Management Agency ("TLMA Director") shall determine the Project Area in writing based on the development plan submitted to the Planning Department and other available information. After determining the Project Area, the TLMA Director may require the applicant for a development plan to have a registered civil engineer or a licensed land surveyor prepare and submit for his approval an exhibit that clearly delineates the Project Area."

Section 2. Subsection b. of Section 13 of Ordinance No. 659 is amended to read as follows:

"b. If the difference between the gross acreage, as shown on the development plan submitted to the Planning Department, and the Project Area is less than one-quarter acre, the fees shall be charged on the gross acreage."

Section 3. Subsection c. of Section 13 of Ordinance No. 659 is deleted in its entirety.

Section 4. Subsection d. of Section 13 of Ordinance No. 659 is relettered subsection c.

Section 5. This ordinance shall take effect thirty days after its adoption.
