#### **BACKGROUND:**

Summary

On December 3, 2013, this Board received the declaration of the Code Enforcement Officer in the above referenced matter and declared the construction without permit located on the subject property to be a public nuisance. The Board ordered the property owner to abate the violative conditions on the property and directed County Counsel to prepare Findings of Fact, Conclusions and Order to Abate.

	FINDINGS OF FACT, CONCLUSIONS AND ORDER TO ABATE NUISANCE  1  JAN 28 2014 2-9					

1. Documents of record in the Riverside County Recorder's Office identify the owner of THE PROPERTY as OWB REO, LLC ("OWNER").

- 2. Documents of title indicate that other parties potentially hold a legal interest in THE PROPERTY, to-wit: Rashmi and Barbara Bhatt (hereinafter collectively referred to as "INTERESTED PARTIES").
- 3. THE PROPERTY was inspected by Code Enforcement Officers on May 19, 2011, March 14, 2012, April 27, 2012, March 18, 2013, September 25, 2013, November 4, 2013, November 27, 2013 and December 2, 2013.
- 4. During the inspections, an unpermitted pool and retaining wall were observed on THE PROPERTY.
- 5. THE PROPERTY was determined to be in violation of Riverside County Ordinance No. 457 by the Code Enforcement Officer.
- 6. A Notice of Noncompliance was recorded on November 16, 2010, as Document Number 2010-0553183 in the Office of the County Recorder, County of Riverside. A Notice of Pendency of Administrative Proceedings was recorded in the Office of the County Recorders, County of Riverside, State of California on June 4, 2012, as Instrument Number 2012-0255422.
- 7. On May 19, 2011, Notice of Violation was posted on THE PROPERTY. On June 10, 2011, June 6, 2012, March 21, 2013, April 17, 2013, September 24, 2013, a Notice of Violation for the construction without permits was mailed to OWNER by first class mail. On March 21, 2013 and April 17, 2013, a Notice of Violation for construction without permit was mailed to OWNER and INTERESTED PARTIES by certified mail, return receipt requested.
- 8. A "Notice to Correct County Ordinance Violations and Abate Public Nuisance" providing notice of the public hearing before the Board of Supervisors on December 3, 2013, was mailed to OWNER and INTERESTED PARTIES and was posted on THE PROPERTY.

#### FINDINGS AND CONCLUSIONS

WHEREFORE, the Board of Supervisors of the County of Riverside, State of California, in regular session assembled on December 3, 2013, finds and concludes that:

FINDINGS OF FACT, CONCLUSIONS AND ORDER TO ABATE NUISANCE

1. WHEREAS, the unpermitted structures (pool and retaining wall) on the real property located at 39625 Calle Cabernet, Temecula, Riverside County, California, also identified as Assessor's Parcel Number 943-270-002 violates RCO No. 457 and constitutes a public nuisance.

- 2. WHEREAS, the OWNER, occupants and any person having possession or control of THE PROPERTY shall abate the unpermitted structures by razing, removing and disposing of the unpermitted structures, including the removal and disposal of all structural debris and materials, and contents therein or obtaining the required permits and approvals, provided that said demolition and/or permitting be accomplished in strict accordance with all Riverside County Ordinances, including but not limited to RCO No. 457 within ninety (90) days.
- 3. WHEREAS, the OWNER AND INTERESTED PARTIES ARE HEREBY FURTHER NOTICED that the time within which judicial review of the administrative determinations made herein must be sought is ninety (90) days from the posting and mailing of the Findings of Fact, Conclusions and Order to Abate Nuisance, and is governed by California Code of Civil Procedure Section 1094.6.

#### ORDER TO ABATE NUISANCE

IT IS THEREFORE ORDERED that the unpermitted structures (pool and retaining wall) on THE PROPERTY be abated by the OWNER, OWB REO, LLC, or anyone having possession or control of THE PROPERTY, by razing and removing the unpermitted structures including the removal and disposal of all structural debris and materials, as well as the contents therein, or obtaining the required permits and approvals for said structures provided such demolition and/or permitting be accomplished in strict accordance with all Riverside County Ordinances, including but not limited to RCO No. 457 within ninety (90) days of the posting and mailing of this Order to Abate Nuisance.

IT IS FURTHER ORDERED that if the unpermitted structures are not razed, removed and disposed of, or permitted in strict accordance with all Riverside County Ordinances, including but not limited to RCO No. 457, within ninety (90) days of the posting and mailing of this Order to Abate Nuisance, the unpermitted structures, contents therein, and structural debris and materials, may be abated by razing, removal and disposal by representatives of the Riverside County Code

contract with a duly certified and licensed contractor for the handling of such materials to avoid

for hearing, shall be imposed as a lien on THE PROPERTY, which may be collected as a special

assessment against THE PROPERTY pursuant to Government Code section 25845 and Riverside

County Ordinance Nos. 457 and 725. Under Riverside County Ordinance No. 725, "abatement

costs" means "any costs or expenses reasonably related to the abatement of conditions which violate

County Land Use Ordinances, and shall include, but not be limited to, enforcement, investigation,

collection and administrative costs, attorneys fees, and the costs associated with the removal or

correction of the violation." Reasonable abatement costs accrued by the Code Enforcement

IT IS FURTHER ORDERED that reasonable abatement costs, after notice and opportunity

FURTHERMORE, the OWNER is ordered to ascertain the existence or non-existence of


